Labour's spring statement and disability cuts – Motion as adjusted approved, after division.

7 Councillor Bell, seconded by Councillor Doherty, moved that:-

"Council notes the transformative work that Glasgow City Council is undertaking to help tackle poverty in the city. Council welcomes the data and insight-driven 'Demonstrators of Change' programme and the workstream of the Child Poverty Programme in ten 'booster wards' across the city which have the highest numbers of children living in relative poverty; and notes that these are piloting and testing different early intervention and prevention approaches, finding out what works for communities, with their input, and scaling up the successes in reducing poverty across the city.

Council agrees with the Resolution Foundation that anti-poverty initiatives like these along with measures like the Scottish Child Payment and universal free school meals are effective ways of lifting people out of poor health and poverty and contribute to the shared aim of the SNP administration in Glasgow and the Scottish Government to work towards eradicating child poverty across the city.

Council is therefore hugely alarmed by the announcements of the UK Chancellor Rachel Reeves and the Work & Pensions Secretary Liz Kendall of cuts to the public sector and the benefits system and believes that these will totally undermine our efforts.

Council believes that the Chancellor's Spring Statement is just the latest example of the Labour Government taking an axe to public services and will mark the beginning of yet another cycle of cuts, harming an increased number of people and leading to higher demand. The announcement of the imposition of further billions of pounds of austerity cuts breaks yet another election promise by both Keir Starmer and Anas Sarwar.

Council notes the UK Government's Spring Statement has done nothing to fix the foundations of the UK economy after the previous Autumn Budget imposed Winter Fuel Payment cuts, increased employers' National Insurance, maintained the cruel Two-Child Benefit Cap, and ignored the Parliamentary and Health Service Ombudsman report which recommended WASPI women should be compensated.

Council further notes that the Spring Statement was preceded by the Secretary of State for Work and Pensions Liz Kendall's Green Paper on health-related benefit reforms which heralded £6 billion a year cuts, and which the Joseph Rowntree Foundation and New Economics Foundation have exposed as the biggest cut to disability benefits since the Office for Budget Responsibility (OBR) was created in 2010.

Council also recognises that this is the largest social security cut since the summer of 2015, when a series of cuts and freezes to the system were implemented that have left the UK with one of the weakest social safety nets in the OECD, according to a NIESR report UK Living Standards Review 2025 published early March.

Council agrees with Scope that, "These plans should shame the government to its core". Council also agrees with the Child Poverty Action Group Scotland "that the Children in a household where someone has a disability already have a higher risk

of poverty and further cuts would only make life harder for many of these families. The UK government's forthcoming child poverty strategy must prioritise investing in the social security system, including by scrapping the two-child limit at source."

Council further recognises that a number of Trade Unions have urged an immediate re-think of the proposed welfare reforms, warning they would disproportionately harm the most vulnerable in society and deepen existing inequalities. Sharon Graham, general secretary of the Unite, has stated that the government is in danger of making the wrong choices and Council agrees with her statement that "We must be protecting the most vulnerable in society and not pitting the poorest against the poorest."

Council rejects the callous treatment of disabled and sick people and confirms its belief that there is no moral case for propelling even more people into poverty by cutting benefit levels or denying access to financial support to those who have no alternative, and that people with disabilities should not a scapegoat for a failing economy and are a community that deserves improved opportunities.

Council believes that the effects of the UK government's proposals will be to make more people sicker, further undermine everyone's right to a decent quality of life and further entrench the barriers to access, employment, and social inclusion that many disabled people face.

Council calls again on the Labour UK Government to scrap the cruel two-child limit and notes that this was one of the UN Committee on Economic, Social and Cultural Rights (CESCR) series of recommendations to tackle poverty in the UK.

Council believes that it is unacceptable that the people of Glasgow continue to pay for their economic incompetence and indifference to poverty of successive UK governments, and instructs the Chief Executive to write to Scottish Labour Leader Anas Sarwar and the UK Labour Prime Minister to highlight the data available in Glasgow that confirms that the choices of the UK government will have the effect of punching down on the poorest and undermining the innovative anti-poverty work of Glasgow City Council."

Councillor Redmond, seconded by Councillor Turner, moved as an amendment to delete all after the first paragraph and insert the following:

"However, Council recognises the progress made by the Labour Government since taking office in delivering meaningful change for people in Glasgow and across Scotland.

This includes the introduction of the New Deal for Working People—a UK-wide programme of employment law reform that will apply in Scotland—strengthening workers' rights by combating exploitative zero-hour contracts, tackling fire and rehire practices, enhancing trade union protections, and introducing day-one rights to sick pay, parental leave, and protection from unfair dismissal.

Council also notes the record £5.5 billion devolution settlement—the largest since the establishment of the Scottish Parliament—which provides substantial resources

for Scotland to invest in local priorities, including health, education, housing, and transport.

Additionally, Council welcomes the UK Labour Government's commitment to addressing the housing crisis through substantial investment and reform, including:

- A £5bn housing investment package for 2025/26, including an immediate £500m top-up to the Affordable Homes Programme – expected to deliver 5,000 new affordable homes.
- A pledge to build 1.5m new homes over the lifetime of this Parliament, the most ambitious national housebuilding drive since the 1960s.

Council further welcomes the UK Labour Government's long-term investment commitments, such as the Green Prosperity Plan, which will support the transition to a low-carbon economy, create skilled jobs in green industries, and fund large-scale retrofit programmes to tackle fuel poverty and reduce household energy bills.

Nonetheless, Council recognises the recent public disquiet over proposals for reforms to the disability and health-related benefits system and acknowledges the serious concerns raised by campaigners, trade unions, and communities across Glasgow.

Council therefore affirms that any reform to the social security system must be underpinned by the principles of dignity, fairness, and compassion.

Council therefore calls on the Chancellor to reconsider the potential impact of any proposed changes and urges the UK Government to explore fair and progressive alternatives to welfare cuts.

Council recognises the importance of exploring fair and progressive alternatives to welfare cuts, and believes that alternative proposals should be considered, including:

- Equalising Capital Gains Tax rates with Income Tax to ensure that income from wealth is taxed fairly.
- Reforming Corporation Tax to ensure that profitable companies contribute appropriately to the public purse.
- Introducing a Financial Transaction Tax to raise revenue from high-frequency trading and speculative financial activity.
- Implementing a modest Wealth Tax on multimillionaire households.

Council believes these options must be seriously considered if the UK Government is to maintain a fair and sustainable welfare state.

Council further believes that decisions taken at UK level must empower, not hinder, Glasgow's efforts to improve outcomes in areas such as child poverty, employability, and inclusive growth. Council notes that the Labour Government's commitment to strengthening devolution and enabling place-based investment provides Glasgow with the tools to lead local change. However, this must be

matched by a policy environment that safeguards the most vulnerable and supports those who need help the most.

Finally, Council reaffirms that poverty is not inevitable. Through investment, partnership, and fairness, we can build a future where every citizen in Glasgow has the opportunity to thrive."

Bailie Hoy, seconded by Councillor Bruce, moved as an amendment that:-

(1) after the second paragraph "child poverty across the city.", insert the following 2 new paragraphs:

"Council agrees that poverty and Violence against Women and Girls (VAWG) are deeply intertwined creating a vicious cycle where poverty makes women more vulnerable to violence, and violence further entrenches them into poverty, limiting their access to education, housing and the labour market. Council also notes that women are around seven times more likely than men to be out of the labour market due to caring commitments.

Council regrets that the Scottish Government has failed to meet its child poverty reduction targets, however we recognise the barriers that have been put in place to prevent achieving these targets. Council notes that 64% of children in Glasgow in absolute or relative poverty have a lone woman parent and agrees that child poverty should be looked at with a gendered lens.";

- (2) at the fifth paragraph beginning "Council notes the UK Government's", between "Two-Child Benefit Cap," and "and ignored", add "cutting the budget for aid and international development";
- (3) after the sixth paragraph ending "was created in 2010.", insert the following 2 new paragraphs:

"Council notes that the OBR estimates that the welfare cuts package announced in the Spring Statement will save £4.8bn by 2029-30. Council notes that Oxfam is calling for a two per cent wealth tax on those with net assets of over £10 million, which could raise an estimated £24 billion tax revenue each year - £460 million every week - and would only apply to 0.04 per cent of the population - around 20,000 people. Office for National Statistics (ONS) data shows that in the April 2020 to March 2022 period, the wealthiest 1% of households held 10% of all household wealth in Great Britain, which was the same as the proportion held by the least wealthy 50% of households combined. Wealth inequality is widely recognised to be detrimental to the functioning of a society.

Council agrees that a wealth tax, and invest-to-save proposals like creating good green jobs, increasing childcare provision, and improving maternity and paternity conditions, would be a far more effective way of addressing fiscal and labour market concerns, without causing permanent harm to families throughout the country.";

- (4) at the tenth paragraph beginning "Council rejects", between "should not" and "a scapegoat", add "be"; and
- (5) at the final paragraph, remove "punching down on" and replace with "disproportionately penalising".

During the debate Councillor Bell and Bailie Hoy, with the agreement of their seconders, agreed to combine their motion and amendment resulting in the following adjusted motion:-

"Council notes the transformative work that Glasgow City Council is undertaking to help tackle poverty in the city. Council welcomes the data and insight-driven 'Demonstrators of Change' programme and the workstream of the Child Poverty Programme in ten 'booster wards' across the city which have the highest numbers of children living in relative poverty; and notes that these are piloting and testing different early intervention and prevention approaches, finding out what works for communities, with their input, and scaling up the successes in reducing poverty across the city.

Council agrees with the Resolution Foundation that anti-poverty initiatives like these along with measures like the Scottish Child Payment and universal free school meals are effective ways of lifting people out of poor health and poverty and contribute to the shared aim of the SNP administration in Glasgow and the Scottish Government to work towards eradicating child poverty across the city.

Council agrees that poverty and Violence against Women and Girls (VAWG) are deeply intertwined creating a vicious cycle where poverty makes women more vulnerable to violence, and violence further entrenches them into poverty, limiting their access to education, housing and the labour market. Council also notes that women are around seven times more likely than men to be out of the labour market due to caring commitments.

Council regrets that the Scottish Government has failed to meet its child poverty reduction targets, however we recognise the barriers that have been put in place to prevent achieving these targets. Council notes that 64% of children in Glasgow in absolute or relative poverty have a lone woman parent and agrees that child poverty should be looked at with a gendered lens.

Council is therefore hugely alarmed by the announcements of the UK Chancellor Rachel Reeves and the Work & Pensions Secretary Liz Kendall of cuts to the public sector and the benefits system and believes that these will totally undermine our efforts.

Council believes that the Chancellor's Spring Statement is just the latest example of the Labour Government taking an axe to public services and will mark the beginning of yet another cycle of cuts, harming an increased number of people and leading to higher demand. The announcement of the imposition of further billions of pounds of austerity cuts breaks yet another election promise by both Keir Starmer and Anas Sarwar.

Council notes the UK Government's Spring Statement has done nothing to fix the foundations of the UK economy after the previous Autumn Budget imposed Winter Fuel Payment cuts, increased employers' National Insurance, maintained the cruel Two-Child Benefit Cap, cutting the budget for aid and international development and ignored the Parliamentary and Health Service Ombudsman report which recommended WASPI women should be compensated.

Council further notes that the Spring Statement was preceded by the Secretary of State for Work and Pensions Liz Kendall's Green Paper on health-related benefit reforms which heralded £6 billion a year cuts, and which the Joseph Rowntree Foundation and New Economics Foundation have exposed as the biggest cut to disability benefits since the Office for Budget Responsibility (OBR) was created in 2010.

Council notes that the OBR estimates that the welfare cuts package announced in the Spring Statement will save £4.8bn by 2029-30. Council notes that Oxfam is calling for a two per cent wealth tax on those with net assets of over £10 million, which could raise an estimated £24 billion tax revenue each year - £460 million every week - and would only apply to 0.04 per cent of the population - around 20,000 people. Office for National Statistics (ONS) data shows that in the April 2020 to March 2022 period, the wealthiest 1% of households held 10% of all household wealth in Great Britain, which was the same as the proportion held by the least wealthy 50% of households combined. Wealth inequality is widely recognised to be detrimental to the functioning of a society.

Council agrees that a wealth tax, and invest-to-save proposals like creating good green jobs, increasing childcare provision, and improving maternity and paternity conditions, would be a far more effective way of addressing fiscal and labour market concerns, without causing permanent harm to families throughout the country.

Council also recognises that this is the largest social security cut since the summer of 2015, when a series of cuts and freezes to the system were implemented that have left the UK with one of the weakest social safety nets in the OECD, according to a NIESR report UK Living Standards Review 2025 published early March.

Council agrees with Scope that, "These plans should shame the government to its core". Council also agrees with the Child Poverty Action Group Scotland "that the Children in a household where someone has a disability already have a higher risk of poverty and further cuts would only make life harder for many of these families. The UK government's forthcoming child poverty strategy must prioritise investing in the social security system, including by scrapping the two-child limit at source."

Council further recognises that a number of Trade Unions have urged an immediate re-think of the proposed welfare reforms, warning they would disproportionately harm the most vulnerable in society and deepen existing inequalities. Sharon Graham, general secretary of the Unite, has stated that the government is in danger of making the wrong choices and Council agrees with her statement that "We must be protecting the most vulnerable in society and not pitting the poorest against the poorest."

Council rejects the callous treatment of disabled and sick people and confirms its belief that there is no moral case for propelling even more people into poverty by cutting benefit levels or denying access to financial support to those who have no alternative, and that people with disabilities should not be a scapegoat for a failing economy and are a community that deserves improved opportunities.

Council believes that the effects of the UK government's proposals will be to make more people sicker, further undermine everyone's right to a decent quality of life and further entrench the barriers to access, employment, and social inclusion that many disabled people face.

Council calls again on the Labour UK Government to scrap the cruel two-child limit and notes that this was one of the UN Committee on Economic, Social and Cultural Rights (CESCR) series of recommendations to tackle poverty in the UK.

Council believes that it is unacceptable that the people of Glasgow continue to pay for their economic incompetence and indifference to poverty of successive UK governments, and instructs the Chief Executive to write to Scottish Labour Leader Anas Sarwar and the UK Labour Prime Minister to highlight the data available in Glasgow that confirms that the choices of the UK government will have the effect of disproportionately penalising the poorest and undermining the innovative anti-poverty work of Glasgow City Council."

On a vote being taken electronically and by roll call, 29 members voted for the amendment by Councillor Redmond and 47 for the motion as adjusted with 2 abstentions.

The motion as adjusted was accordingly declared to be carried.

Women's safety in Glasgow - Motion as adjusted approved.

10 Bailie Siddique, seconded by Councillor Pidgeon, moved that:-

"Council recognises that women's safety is a fundamental right and that no woman or girl in Glasgow should feel unsafe in public spaces, workplaces, or on public transport. However, evidence continues to show that many women do not feel safe, particularly at night.

Council acknowledges that International Women's Day 2025, themed #AccelerateAction, provided an opportunity to celebrate women's achievements while also recognising the urgent need to improve women's safety. Across Glasgow, various organisations marked the occasion, including the Glasgow

University Students' Representative Council's Brewing Connections event, Smart Works Scotland's collaboration with Hobbs Glasgow to support women in employment, and the Mitchell Library's Spectacular Scottish Women creative writing workshop. While these initiatives are welcomed, Council recognises that symbolic events alone are not enough to address the deep-rooted issues affecting women's safety.

Council notes with deep concern that Police Scotland has lost approximately 575 officers since 2020, including around 63 officers in Glasgow, significantly reducing visible policing in communities. At the same time, budget cuts at Glasgow City Council mean that while CCTV continues to operate 24/7, it is no longer monitored around the clock, resulting in slower response times and increased vulnerability in critical situations. These cuts have heightened safety concerns, particularly for women, and threaten to undermine efforts to address harassment, anti-social behaviour, and violence.

Council also notes the findings from the Safe Glasgow Partnership, which show that domestic violence against women in Glasgow has increased by 41.2% when compared to the PYTD, and by 47.7% compared to the five-year mean. Rape has increased by 40.6% compared to PYTD and by 50.6% from the five-year mean. Sexual assault has increased by 28.1% PYTD and by 25.1% compared to the five-year mean. These alarming trends reinforce the need for urgent and sustained action.

Council is deeply alarmed by global statistics that highlight the scale of violence against women. The 2023 UN Femicides Report revealed that 85,000 women were intentionally killed by men, with 60% of these cases involving perpetrators who were partners or family members - demonstrating that much of this violence occurs within the home.

Council believes that addressing women's safety must be a city-wide priority and that urgent action is needed to restore confidence in public spaces. It is unacceptable that women are being forced to modify their behaviour - changing routes, avoiding certain areas, or feeling unable to travel alone - because of inadequate public safety measures.

Council recognises that women's safety is directly linked to the primary prevention of Violence Against Women and Girls (VAWG), which requires tackling the root cause of gender inequality. Furthermore, it is vital to recognise the intersectionality of women's experiences. Women of colour, disabled women, LGBTQ+ women, and other marginalised groups often face compounded discrimination and additional barriers to safety and support. Their voices must be included in the development of policies and services to ensure an inclusive and equitable response.

Therefore, Council resolves to:

 Develop a Glasgow Women's Safety Action Plan, bringing together key partners - including the Council, Police Scotland, public transport providers, businesses, and community organisations - to identify and implement practical safety improvements.

- Conduct a city-wide consultation to gather direct input from women and local groups on key safety concerns and potential solutions, ensuring inclusive outreach to women of colour and other marginalised groups.
- Work with Police Scotland to protect frontline policing levels in Glasgow.
- Consider how support services for women can be strengthened to ensure that they are accessible and inclusive.
- Promote bystander intervention and workplace safety initiatives, encouraging businesses, hospitality venues, and public spaces to adopt measures such as the Ask for Angela scheme.
- Explore the introduction of a Glasgow Women's Safety Charter, setting clear commitments for organisations across the city to create safer environments for women.
- Agree that Glasgow City Council and Police Scotland should organise an emergency summit on violence against women and girls to coordinate immediate and long-term actions.
- Call on the Scottish Government to provide targeted additional support to areas experiencing high levels of violence against women and girls.
- Call for the establishment of specialist units dedicated to the reduction of violence against women and girls, and that this initiative be incorporated into the next Police Plan for Glasgow."

Bailie McTaggart, seconded by Bailie McCabe moved as an amendment to delete all and replace with the following:

"Council believes that violence against women and girls (VAWG) is both a cause and a symptom of gender inequality and that prevalence statistics show that women and children are disproportionately affected by men's violence. Council further believes that to make sense of the nature and scale of VAWG and to understand how we can stop it, it is essential to understand it as being caused by men's behaviour in the context of systems and cultures in which inequality between men and women remains deeply rooted.

Council regrets that great deal of the conversation around VAWG that has emerged in recent years has centred on framing VAWG as an issue of individual women's 'safety' that can be addressed through measures such as CCTV and street lighting; measures we know do not address the root causes of VAWG, particularly given that the majority of perpetrators of VAWG are known to the victim or survivor, as stated by the End Violence Against Women Coalition (EVAW) a leading coalition of more than 120 specialist women's support services, researchers, activists, victims and survivors and NGOs working to end violence against women and girls in all its forms.

Council is deeply alarmed by global statistics that highlight the scale of violence against women. The 2023 UN Femicides Report revealed that 85,000 women were intentionally killed by men, with 60% of these cases involving perpetrators who were partners or family members-demonstrating that much of this violence occurs within the home.

Council also notes the findings from the Safe Glasgow Partnership, which show that reported domestic violence against women in Glasgow has increased by 41.2% when compared to the PYTD, and by 47.7% compared to the five-year mean. Reported rape has increased by 40.6% compared to PYTD and by 50.6% from the five-year mean. Reported sexual assault have increased by 28.1% PYTD and by 25.1% compared to the five-year mean. These alarming trends reinforce the need for urgent and sustained action to address the root causes of VAWG. However, Council also recognises that increased reporting can also be an indication of crimes against women being recorded more rigorously and welcomes that crimes against women, which always took place but were hidden, are now made visible and discussed more openly and that activities such as stalking, revenge porn, and 'upskirting' are now recognised and recorded as offences. Council commends the work of women's support organisations, including partners in the Glasgow Violence Against Women Partnership, whose campaigning over many years has played a vital role in pushing VAWG further up the public agenda and encouraging women to report crimes against them.

Council believes that women's safety is a fundamental right and that, while the vast majority of VAWG takes place in or near domestic dwellings, it is also important that no woman or girl in Glasgow should feel unsafe in public spaces, workplaces, or on public transport. However, evidence continues to show that many women do not feel safe, particularly at night. Council believes that it is unacceptable that women feel forced to modify their behaviour - changing routes, avoiding certain areas, or feeling unable to travel alone - because of inadequate public safety measures harassing, threatening or violent male behaviour in public spaces. While recognising that it is not places themselves that make women unsafe, Council nonetheless acknowledges that inclusive urban planning measures can help to increase women's confidence in public spaces and commends the ongoing work of the Feminist Urban Planning working group, which is exploring ways to make Glasgow feel safer and more inclusive for women and other groups such as LGBTQ+ people, disabled people and people of colour.

- Welcomes the has creation of a dedicated a funding stream for VAW in the latest Glasgow Community Fund (GCF), and commits to building on the expertise of the existing VAW funded projects.
- Commends Glasgow city Council achieving the Equally Safe at Work
 Development award in 2024, and how the Council is now working towards the
 Equally Safe at Work Bronze award that focuses on
 - Promoting gender equality.
 - Preventing gender-based violence.
 - Fostering a safe and inclusive workplace culture.
- Notes that the GCC Feminist Urbanism supported by a cross-party Political Oversight Group work sets a clear commitment to create safer environments for women and girls.
- Notes that the Scottish Government has provided £2,074,875.47 funding from the Delivering Equally Safe, (DES) investing in VAW services in Glasgow, and that DES funding has been confirmed for 26/26 and 26/27 from the DES, and the Scottish government has also appointed a Sustainable Funding Project Board to oversee the development of a sustainable funding model for violence against women and girls' services."

Councillor Bruce, seconded by Councillor Gallagher, moved as an amendment that:

 - (c) remove final sentence beginning "These cuts have...";
- (3) after the fifth paragraph ending "...within the home.", insert the following 3 new paragraphs:

"Council recognises that men and boys have a responsibility to prevent violence against women and girls, and believes that educating boys and young men about issues like misogyny, consent and healthy masculinity is crucial. Council welcomes recent progress in the delivery of gender equality education initiatives but recognises that more must be done to prevent gender-based violence in schools. Council therefore regrets that the Scottish Government has further delayed introduction of revised Relationships, Sexual Health and Parenthood guidance, the draft of which emphasised the importance of consent.

A report by Young Women UK found that young women who had experienced misogyny were five times more likely to suffer from clinical depression and experience long term impact. Council acknowledges the dire need to invest in our mental health services to provide immediate support whilst tackling education around the issue.

Council notes that at the recent IJB budget meeting, there were significant cuts across mental health services including the counselling service offered at the Sandyford Clinic in Glasgow, which supports survivors of rape and sexual abuse and has a significant waitlist. Council acknowledges that there is a high demand for these specialist services.";

 - Explore the introduction of a Glasgow Women's Safety Charter, setting clear commitments for organisations across the city to create safer environments for women.
 - Agree that Glasgow City Council and Police Scotland should organise an emergency summit on violence against women and girls to coordinate immediate and long-term actions.
 - Call on the Scottish Government to provide targeted additional support to areas experiencing high levels of violence against women and girls
 - Call for the establishment of specialist units dedicated to the reduction of violence against women and girls, and that this initiative be incorporated into the next Police Plan for Glasgow.; and
- (d) add the following new resolutions to the end of the list of resolutions:
 - Write to the Scottish Government to call for more targeted additional support to both Glasgow City Council and to areas experiencing high levels of violence against women and girls services in the city.
 - Write to the Scottish Government to table the Misogyny Bill before the end of this parliamentary term which proposes to criminalise abusive and humiliating behaviour directed at women and girls.
 - Write to the Education Secretary affirming Glasgow City Council's view that the finalised RSHP guidance should be introduced before the start of the new school year.
 - Write to the Scottish Government outlining the devastating impact that closing the Sandyford's Counselling Service will have on its service users.
 - Support the provision of improved training for school staff to engage with children and young people on issues of misogyny, gender-based violence and gender inequality.
 - Bring forward a Glasgow City Council delivery plan for the "Preventing and responding to gender based violence: a whole school framework" to the Education, Skills and Early Years City Policy Committee.
 - Introduce a Healthy Masculinity Action Plan for boys and young men with a focus on healthy emotions, positive male role models,

and constructive conflict resolution. This should include: promoting the uptake of in-school mental health services amongst boys and young men and a review of how RSHP is effectively delivered, to be informed by young people's views."

Council commends the work of women's support organisations, including partners in the Glasgow Violence Against Women Partnership, whose campaigning over many years has played a vital role in pushing VAWG further up the public agenda and encouraging women to report crimes against them. However, violence against women and girls continue to remain underreported.

Council recognises that men and boys have a responsibility to prevent violence against women and girls, and believes that educating boys and young men about issues like misogyny, consent and healthy masculinity is crucial. Council welcomes recent progress in the delivery of gender equality education initiatives but recognises that more must be done to prevent gender-based violence in schools. Council therefore regrets that the Scottish Government has further delayed introduction of revised Relationships, Sexual Health and Parenthood guidance, the draft of which emphasised the importance of consent.

A report by Young Women UK found that young women who had experienced misogyny were 5 times more likely to suffer from clinical depression and experience long term impact. Council acknowledges the dire need to invest in our mental health services to provide immediate support whilst tackling education around the issue.

Council notes that at the recent IJB budget meeting, there was significant cuts across mental health services including the counselling service offered at the Sandyford Clinic in Glasgow, which supports survivors' rape and sexual abuse and has a significant waitlist. Council acknowledges that there is a high demand for these specialist services.

Council believes that addressing women's safety must be a city-wide priority and that urgent action is needed to restore confidence in public spaces. It is unacceptable that women are being forced to modify their behaviour—changing

routes, avoiding certain areas, or feeling unable to travel alone—because of inadequate public safety measures.

Council recognises that women's safety is directly linked to the primary prevention of Violence Against Women and Girls (VAWG), which requires tackling the root cause of gender inequality. Council agrees that Violence against Women and Girls (VAWG) is both a cause and consequence of gender inequality, rooted in harmful social norms and patriarchal structures that perpetuate male power and control.

Furthermore, it is vital to recognise the intersectionality of women's experiences. Women of colour, disabled women, LGBTQ+ women, and other marginalised groups often face compounded discrimination and additional barriers to safety and support. Their voices must be included in the development of policies and services to ensure an inclusive and equitable response.

Therefore, Council resolves to:

- Implement the updated GVAWP city wide strategic plan and implementation plan that is now realigned to the Equally Safe refresh and the Scottish Government/ COSLA's commitment to preventing and eradicating violence and addressing the underlying attitudes and systems that perpetuate it.
- Continue to act upon the findings of the GVAWP funded Wise Women led 2021 /22 women's safety survey developed in collaboration with Commonplace and Glasgow Girls Club and focus groups of women, most recently this work influencing the development of Where We Stop and Sophie's Stop
- Welcomes the creation of a dedicated a funding stream for VAW in the latest Glasgow Community Fund (GCF), and commits to building on the expertise of the existing VAW funded projects.
- Commends Glasgow city Council achieving the Equally Safe at Work Development award in 2024, and how the Council is now working towards the Equally Safe at Work Bronze award that focuses on promoting gender equality, preventing gender-based violence, fostering a safe and inclusive workplace culture.
- Notes that the Scottish Government has provided £2,074,875.47 funding from the Delivering Equally Safe, (DES) investing in VAW services in Glasgow, and that DES funding has been confirmed for 26/26 and 26/27 from the DES, and the Scottish government has also appointed a Sustainable Funding Project Board to oversee the development of a sustainable funding model for violence against women and girls' services.
- Agree to a refresh of the Glasgow Women's Safety Action Plan.
- Conduct a city-wide consultation on the Glasgow Violence Against Women and Girls Partnership's (GVAWP) strategy to gather direct input from women

- and local groups on key safety concerns and potential solutions, ensuring inclusive outreach to women of colour and other marginalised groups.
- Consider how support services for women can be strengthened to ensure that they are accessible and inclusive.
- Promote bystander intervention and workplace safety initiatives, encouraging businesses, hospitality venues, and public spaces to adopt measures such as the Ask for Angela scheme.
- Agree that Glasgow City Council in conjunction with MARAC, GVAWP and Police Scotland organise an event to consult stakeholders on how to more effectively combat Violence against Women and Girls.
- Call for the enhancement of specialist units dedicated to the reduction of violence against women and girls, and that this initiative be incorporated into the next Police Plan for Glasgow.
- Write to the Scottish Government for more targeted additional support to both Glasgow City Council and to areas experiencing high levels of violence against women and girl's services in the city.
- Write to the Scottish Government to encourage them to table the Misogyny Bill before the end of this parliamentary term which proposes to criminalise abusive and humiliating behaviour directed at women and girls before the end of this Parliamentary term.
- Write to the Education Secretary affirming Glasgow City Council's view that the finalised RSHP guidance should be introduced before the start of the new school year.
- Write to the Scottish Government to encourage them to table the devastating impact that closing the Sandyford's Counselling Service will have on its service users.
- Support the provision of improved training for school staff to engage with children and young people on issues of misogyny, gender-based violence and gender inequality including commissioning the development of suitable training modules to help staff engage with pupils.
- Bring forward a Glasgow City Council delivery plan for the "Preventing and responding to gender based violence: a whole school framework" to the Education, Skills and Early Years City Policy Committee.
- Introduce a Healthy Masculinity Action Plan for boys and young men with a
 focus on healthy emotions, positive male role models, and constructive
 conflict resolution. This should include: promoting the uptake of in-school
 mental health services amongst boys and young men and a review of how
 RSHP is effectively delivered, to be informed by young people's views.

Building on the groundbreaking Education Services Girls4Equality work as
discussed at the 13th March 2025 Committee and continue to engage and
consult with girls regarding their experience of misogyny and similarly to
Glasgow's pioneering Period dignity work co-create a response with them and
boys based on their feedback."

The motion, as adjusted, was unanimously approved.

Council therefore agrees to write to both UK and Scottish Governments and to COSLA making it clear that current funding for health and social care is inadequate, that IJBs are being forced to make decisions which will actively harm some of the most vulnerable, that there needs to be a substantial increase in the funding of community health and social care services, and calls on all levels of Government to work together to address this growing crisis."

Councillor Cunningham, seconded by Councillor Casey, moved as an amendment:-

(1) to insert the following after the third paragraph:

"Council notes that across Scotland since the 2011 census there has been a continued increase in the over 65 age population, an increase in those reporting ill health and an increase in those providing unpaid care, all of which

are the product of both long term demographic trends and the continued legacy of the Covid pandemic. The challenges require us to provide care concentrated on retaining people's independence and to create an inclusive culture where more people of all ages play a positive role in society.

Recent data shows that despite real terms increases in IJB funding, the majority of IJB's reported a deficit on the cost of providing services and required additional funding from partner bodies and/or use of reserves, alongside reductions in services, in order to break even."; and

(2) to add the following at the fourth paragraph after "in funding and in the way that funding is administered":

"Council further agrees that the pressures on Scotland's social care and healthcare services are escalating, with higher demand, workforce difficulties, and financial strains, further aggravated by inflationary cost pressures.

Council notes the cuts announced in the UK Government Spring Statement and Green Paper on disability reform, and how we are limited by being part of the UK; the system of funding allocation meaning that cuts to funding in England impact on the money that Scotland receives for its health services. Austerity measures and welfare reform have had a significant impact on large numbers of people who are already bearing the poorest health and will continue to do so for years to come.

Council believes that people should be supported to live the healthiest lives possible, and that prevention and early intervention is key to achieving this and how we must take every opportunity to strengthen the foundations for good health especially tackling income inequality.

Council reiterates the core principles of the IJB's Strategic Plan, which calls for 'a transformational change in how it supports individuals, families and communities to live independently from statutory services for as long as they can safely do so' by 'focusing our resources and our energies on prevention and early intervention'.

Council believes that government should focus and channel resources to support the principles set out in this resolution and to that end should develop the means and methodologies to ensure delivery of such funding."

Bailie Raja, seconded by Bailie Jenkins, moved as an amendment to delete the fifth paragraph and insert the following:

"Council acknowledges the concerns raised regarding the funding of health and social care services. However, Council notes that health and social care are devolved matters, and the responsibility for funding and prioritising these services rests with the Scottish Government. While the UK Government has provided a record £5billion Devolution Settlement to the Scottish Government, it is the Scottish Government's allocation of these funds that determines the level of investment in these services. Council, therefore, calls on the Scottish Government to prioritise

adequate funding for health and social care services, ensuring that resources are effectively allocated to protect and support vulnerable communities"

During the debate Councillor Molyneux and Councillor Cunningham, with the agreement of their seconders, agreed to combine their motion and amendment resulting in the following adjusted motion:-

Automatic voter registration – Motion as adjusted approved.

14 Councillor Alex Kerr, seconded by Councillor Hepburn, moved that:-

"Council firmly believes that a strong democracy is the foundation stone on which the most prosperous and free societies that have existed throughout history have been built. Council further believes that ensuring the largest proportion of citizens possible are able to take part in the democratic process, known as "democratic well-being" is crucial to ensuring the long-term strength of any democratic system. Council understands the additional barriers that those from more deprived backgrounds face in engaging with the democratic process with the Fraser of Allander institute finding a significant gap in participation between individuals that

considered themselves in good health and those that considered themselves in bad health.

Council deplores the introduction of voter ID legislation by the UK Government which requires those taking part in Westminster elections to show photographic identification to vote in a polling station. Council notes the Electoral Commissions report into the May 2023 Local Elections in England which took place under the voter ID rules which found hundreds of thousands of people could be excluded from voting in a UK general election because of new rules. Council further notes the reports finding that this would have a disproportionate impact on poorer people, those with disabilities and from minority ethnic backgrounds.

Council notes that the Scottish Government passed amendments to the Scottish Elections (Representation and Reform) Act at the Scottish Parliament following consultation to enable the possibility of similar automatic voter registration pilots being pursued at a local authority level with a view to widening participation at Scottish and Local levels.

Council considers this would meet the aims of increasing democratic well-being by widening the pool of those eligible to vote and removing unnecessary barriers from participation in the democratic process to some of the most deprived communities. Council further believes the success of such pilots would highlight the benefits of taking an approach which opens up democracy, as opposed to inadvertently closing routes into participation through implementation of unnecessary voter ID legislation which creates barriers to participation.

Council notes Glasgow City Council's success in the area of using data to increase participation – particularly with Glasgow's pilot canvass which was cited by the Electoral Commission as best practice with findings being used to inform UK wide changes to the canvass. Council believes that given this track-record of success that Glasgow City Council should volunteer as a lead pilot location for an automatic voter registration pilot with the Scottish Government.

Council further notes the low turnout at recent by-elections and reflects that more visible methods to raise awareness of elections for citizens could have assisted in improving turnout. Council recognises that there has been a blanket ban on election advertising for some time but believes a partial repeal of this ban could be explored with the aim to increase democratic engagement.

Council therefore requests that Officers put forward the Glasgow as a location for an automatic voter registration pilot with the Scottish Government; and agrees to bring a paper to the Wellbeing, Equalities, Communities, Culture and Engagement City Policy Committee within the next two cycles before summer recess 2025 to explore the possibility of this and report back on other ways including the use of data that the Council could use to increase democratic participation and wellbeing."

Bailie Lalley, seconded by Councillor Mooney, moved as an amendment that:-

(1) at the first paragraph delete all after "Council firmly believes" and insert:

"that a strong and inclusive democracy is a foundation of a fair society, and that increasing voter participation—particularly among underrepresented groups—strengthens democratic legitimacy and wellbeing.";

(2) at the second paragraph delete in full and insert:

"Council acknowledges that changes to voter ID rules for UK parliamentary elections have raised concerns about potential barriers to participation. Council believes that steps should be taken to ensure all eligible citizens are supported to vote, and that targeted support should be made available to those at risk of exclusion.":

(3) at the fourth paragraph "removing unnecessary barriers", insert:

"and ensuring that proposals are underpinned by robust planning, safeguards, and community engagement.";

(4) at the fifth paragraph referencing Glasgow City Council's success insert at the end:

"Council further believes any pilot should involve close collaboration with Electoral Registration Officers and local community groups to ensure delivery is tailored to local needs.":

(5) after the fifth paragraph insert the following new paragraph:

"Council believes that any automatic voter registration pilot must be underpinned by a clear implementation framework and appropriate resourcing. Council further believes that efforts to improve democratic participation must be supported by enhanced civic education, outreach work with communities experiencing low turnout—including young people, disabled citizens, and Black, Asian and Minority Ethnic communities—and collaboration with third sector organisations already working to engage underrepresented voters.";

(6) after new paragraph above insert the following additional paragraph:

"Council believes that improving access to voting must go hand-in-hand with maintaining public trust in the electoral system, and that measures aimed at widening participation should be implemented in a way that enhances transparency, security, and confidence in electoral outcomes.";

(7) at the final paragraph after "increase democratic participation and wellbeing," insert:

"including civic education initiatives and targeted community outreach,"; and

(8) add at end of the final paragraph:

"Council also agrees to explore the possibility of revising existing restrictions on public election advertising in a limited and controlled way, with safeguards to ensure fairness, transparency, and cost-effectiveness."

Bailie Carroll, seconded by Councillor Anderson, moved as an amendment that:-

- (1) at the second paragraph beginning "Council deplores...", between "...new rules." and "Council further notes...", add:

Council believes that, if city-wide automatic voter registration is not taken forward, as a minimum the Scottish Government should work with Glasgow City Council to pilot automatic voter registration in the city's council-run schools, coupled with in-school efforts to promote democratic engagement, ahead of Scottish and local elections in 2026 and 2027."; and
- (4) after the final paragraph, insert the following additional paragraph:
 - "Council requests that the Convener for Open Government write to each of Glasgow's MPs to confirm their positions on Voter ID requirements for Westminster Elections, and what they will do to address disenfranchisement thanks to Voter ID. Glasgow Low Emission Zone Community Support Fund – Funding approved - Authority to Executive Director of Neighbourhoods, Regeneration and Sustainability - Declaration of interest.

- 1 Councillor Millar, City Convener for Climate, Glasgow Green Deal, Transport and City Centre Recovery, presented a report regarding the proposed allocation of funding from the Low Emission Zone (LEZ) fund, advising
- (1) that the Council in 2018, had introduced Scotland's first LEZ which targeted emissions from the bus fleet and required progressive improvements in the number of cleaner buses entering the city centre with the full Glasgow LEZ, which applied to all vehicle types, coming into effect on 31st May 2022, followed by a 1 year grace period before general enforcement of the emissions-based entry conditions began on 1st June 2023;
- that non-compliant vehicles entering the LEZ were subject to penalty charges and legislation required that any income received through enforcement of the LEZ was firstly allocated to the ongoing costs of operating the scheme with any residual revenue being allocated to facilitating (directly or indirectly) the achievement of the scheme's objectives, as detailed in the report;
- (3) that the Council on 16th February 2023 (Print 6, page 577) had approved the allocation of £250,000 of the 2023/24 LEZ revenues for funding for community organisations to advance projects which supported the objectives of the LEZ

and this funding formed the basis for the LEZ Community Support Fund which would enable funding of between £20,000 to £50,000 per project being allocated to groups and organisations to deliver complementary projects across the city, as detailed in the report;

- (4) that applications for funding from the LEZ Community Support Fund had opened on 2nd December 2024, with a closing date of 31st January 2025 and the fund was significantly over-subscribed, with 61 applications being received and as a result, 2 rounds of initial screening of applications were conducted by officers within Neighbourhoods, Regeneration and Sustainability which resulted in 22 applications being progressed for assessment, as detailed in the report;
- that the Council on 20th February 2025 (Print 7, page 7) approved the 2025/26 budget and agreed that a further £235,000 of LEZ revenues from the 2024/25 financial year be directed to the LEZ Community Support Fund and that £247,000 from the 2023/24 financial year be allocated for this purpose in addition to the £250,000 of LEZ revenues from the 2023/24 financial year, making a total of £732,000 of funding available for the fund and it was proposed that these monies be allocated to the projects, as detailed in Appendix 1 to the report;
- (6) that it was proposed that a further round of LEZ Community Support Fund applications be opened for the remaining funds from this year's allocation, with the same evaluation process being used and that the Executive Director of Neighbourhoods, Regeneration and Sustainability be authorised to determine and approve any further applications for LEZ Community Support, as detailed in the report; and
- (7) of the next steps.

After consideration, the committee

- (a) approved
 - (i) the recommendations for funding from the LEZ Community Support Fund assessment panel and the Climate and Sustainability Board; and
 - (ii) the allocation of £247,000 from the 2023/24 financial year to the fund;
- (b) agreed to the disbursal of any remaining and future LEZ Community Support Fund budget and authorised the Executive Director of Neighbourhoods, Regeneration and Sustainability to determine and approve further LEZ Community Support Fund applications. having regard to recommendations made by the Climate and Sustainability Board; and
- (c) noted the proposed timeline and process for awarding funds and completing projects.

In terms of Standing Order No 27, Councillor Lana Reid-McConnell declared an interest in this item of business and left the meeting and took no part in the discussion or decision thereon.

Budget monitoring reports noted and budget adjustments approved.

2 Councillor Bell, Depute Leader of the Council, City Treasurer and City Convener for Financial Inclusion, presented reports on the 2024/25 revenue budget and on the investment programme, both for the period from 1st April 2024 to 7th February 2025.

After consideration, the committee

- noted the reports and that they, together with detailed service reports, would be considered by the Finance and Audit Scrutiny Committee in due course;
 and
- (2) approved the detailed budget adjustments relating to the revenue budget and the investment programme, as detailed in the reports.

Child poverty programme – Investing in Calton (Ward 9) - Clyde Gateway Urban Regeneration Company - Whole Family Early Intervention Funding approved - Declaration of interest.

- 3 Councillor Bell, Depute Leader of the Council, City Treasurer and City Convener for Financial Inclusion, presented a report regarding the proposed commitment and investment of £1.2m from the Whole Family Early Intervention Fund (WFEIF) to Clyde Gateway Urban Regeneration Company (CGURC), advising
- (1) that 3 wards, namely Southside Central (Ward 8), Calton (Ward 9) and Govan (Ward 5) had been identified to pilot the Demonstration of Change (DOC) intiative which aimed to tackle poverty, improve long-term outcomes for familes and provide a comprehensive, person-centred approach to early intervention, employment support and overall community wellbeing;
- (2) that the intention was to build any potential solution or system change on the infrastructure of what already existed, and that this change approach had ensured that the voice of local people was absorbed into the reflections and analysis of what needed to be done differently;
- (3) of the key learning to emerge from the child poverty programme and of the approach adopted in the city to implement a series of 3 DOCs to ensure that the voices of local residents shaped the programme's delivery, as detailed in the report;
- of the significant development work that had been carried out over the last year to prepare for the implementation of phase 1 of the Calton DOC;

- (5) that the WFEIF had a total of £22.1m and based on identified need and to support the delivery of the Calton DOC, as detailed in the report, it was proposed that the £1.2m of funding from the WFEIF be allocated to the CGURC and, as a Special Purpose Vehicle established to deliver on behalf of the Council and other partners, the CGURC would be able to drive the delivery of the DOC for the Calton Ward, ensuring the programme's successful implementation and long-term impact;
- (6) that activity was well underway in preparation for full programme delivery from April 2025, with a number of small tests of change having commenced to inform future delivery, as detailed in the report; and
- (7) of the monitoring and evaluation process for the Calton DOC.

- (a) endorsed and supported the work undertaken to date, particularly the development of the community-driven action plan;
- (b) approved an allocation of £1.2m to Clyde Gateway Urban Regeneration Company to deliver the Calton Ward Demonstration of Change, as detailed in the report; and
- (c) noted that the work was now ready to move into the implementation phase, with a clear costed programme and community-backed approach in place.

In terms of Standing Order No 27, Councillors Greg Hepburn and Cecilia O'Lone declared an interest in this item of business and left the meeting and took no part in the discussion or decision thereon.

Queens Park play area renewal (Wards 6, 7 and 8) - City Policy ENV2/IPG Childs Play funding approved – Declaration of interest.

- 4 Councillor Kelly, City Convener for Housing, Development, Built Heritage and Land Use, presented a report regarding the use of City Plan Policy ENV2/IPG Childs Play funding for the renewal of play facilities at Queens Park (Wards 6, 7 and 8), advising that
- (1) a play sufficiency assessment engagement with children locally had identified the play facilities at Queens Park near the Balvicar Street entrance as a popular location for play, however the view was that there should be a greater quantity of play equipment and that the existing play equipment should be repaired or replaced;
- (2) it was proposed that the Council contributed £70,401 of funding from the City Plan Policy ENV2/IPG Childs Play fund for the provision of additional toddler equipment and the provision of climbing structures with platforms of different heights connected by bridges which would help increase the footprint of the

- play area at Queens Park as well as improving the connectivity between the play area and the rest of the park; and
- in accordance with City Plan Policy ENV2/IPG Childs Play fund, the capital cost of £70,401 towards construction works would be supplemented by revenue costs of £17,543 for on-going maintenance costs over a 10-year period.

- (a) noted the contribution from the Scottish Government play area renewal and parks and open spaces funds; and
- (b) approved the use of £87,944 of ENV2/IPG Childs Play fund in support of the renewal of play facilities at Queens Park, near the Balvicar Street entrance.

In terms of Standing Order No 27, Bailie Soryia Siddique declared an interest in this item of business and left the meeting and took no part in the discussion or decision thereon.

Social Care charging policy for 2025/26 approved.

- 5 Councillor Cunningham, City Convener for Health, Care & Caring and Older People, presented a report regarding a revised Social Care charging policy for 2025/26, advising
- (1) that the Social Care charging policy, as detailed in Appendix A to the report, set out the Council's Social Work Services charging policy with a focus on non-residential charging, together with the legislative background to charges for non-residential social care services and described the services to which service user contributions applied, together with minimum income thresholds and tapers, which had been updated to reflect various changes, as detailed in the report; and
- (2) that the annual review process had taken into consideration a range of factors, as detailed in the report and the proposed changes for this year's review to reflect Regulations coming into force on 7th April 2025 were as follows:-
 - (a) an increase in the Local Authority rates to reflect the increased cost of delivery with most charges having a 5% uplift, with the exception of hot meals which would see a 13% uplift;
 - (b) there would be no increase to aids and adaptations, minimal limits or the blue badge administration;
 - (c) an increase to the Minimum Income Thresholds and Interim Charges in accordance with the annual Department for Work and Pensions/Social Security Scotland benefit uplifts;

- (d) a new charge of £100 for the supply and installation of a key box;
- (e) for the transition from analogue to digital telecare, the Community Alarm unit cost for 2025/26 would be held at the existing level of £4.15 and the unit cost would be reviewed for 2026/27 to ensure future cost recovery; and
- (f) the exclusion of Infected Blood Compensation Payments from the financial assessment, in accordance with the new COSLA guidance.

After consideration, the committee approved the revised Social Care charging policy for 2025/26, as detailed in Appendix 1 to the report, as directed by the Integrated Joint Board (IJB) in support of the delivery of Council services in accordance with the IJB's Strategic Plan.

Revenue Estimates 2025/26 – Allocation of budgets within services approved etc.

- With reference to the minutes of the Council of 20th February 2025 (Print 7, page 7) approving the 2025/26 summary Revenue Estimates, Councillor Bell, Depute Leader of the Council, City Treasurer and City Convener for Financial Inclusion, presented a report regarding the detailed allocation of the approved 2025/26 estimates at service level, advising
- (1) of changes to service estimates and net expenditure across services; and
- that in relation to the Glasgow Integrated Joint Board, net direct expenditure budgets totalling £594,938,800 spanning Social Work Services and Neighbourhoods, Regeneration and Sustainability were anticipated.

After consideration, the committee

- (a) approved the adjustments and the detailed Revenue Estimates 2025/26; and
- (b) noted that this would be the basis for the detailed service reports to be considered by the Finance and Audit Scrutiny Committee.

Glasgow's Holiday Programme for Summer and October 2025 and Spring 2026 – Funding awards approved – Declarations of interest.

- 3 Councillor Bell, Depute Leader of the Council, City Treasurer and City Convener for Financial Inclusion, presented a report regarding applications for funding from Glasgow's Holiday Programme for Summer and October 2025 to Spring 2026, advising
- (1) that Glasgow's Holiday Programme provided funding to organisations to deliver a programme of engagement, activities and nutritious food to Glasgow's nursery, primary and secondary pupils, aged 0 to 18 years during school holiday periods;
- that as part of the commitment to regularly review the programme, an online session was held on 30th October 2024 with 2024/25 service providers to reflect on the 2024/25 programme, to discuss and explore any potential improvements in the planning and delivery of the 2025/26 programme and to facilitate a platform for sharing information and learning amongst the providers;
- (3) of the Glasgow Food Policy Partnership;
- (4) of the Scottish Government's commitment to develop an All Age Childcare system;

- that applications for the 2025/26 holiday programme had been sought from third sector organisations and 80 applications were received, with 1 applicant subsequently withdrawing their application, however the remaining 79 applications totalling £2,931,253 were assessed, reviewed and scored by officers against a pre-determined criteria, as detailed in the report;
- (6) that in order to achieve the reach across the city within the available budget, it was proposed that 59 applications totalling £2,220,473 be awarded funding, as detailed in Appendix 1 to the report;
- (7) of the number of projects delivered to service users from each ward and the associated anticipated number of service users, as detailed in Appendix 2 to the report;
- (8) of the 20 applications which had not been recommended for funding, as detailed in Appendix 3 to the report; and
- (9) of the monitoring information from the Summer and October 2024 programmes, as detailed in Appendix 4 to the report.

- (a) approved the award of funding from Glasgow's Holiday Programme for Summer and October 2025 to Spring 2026, as detailed in Appendix 1 to the report; and
- (b) noted
 - the number of projects delivering to service users from each ward, as detailed in Appendix 2 to the report;
 - (ii) the organisations not recommended for funding, as detailed in Appendix 3 to the report; and
 - (iii) the monitoring information from the Summer and October 2024 programmes, as detailed in Appendix 4 to the report.

In terms of Standing Order No 27, Bailie Martha Wardrop and Councillors Allan Casey and Cecilia O'Lone declared an interest in this item of business and left the meeting and took no part in the discussion or decision thereon.

Shared Prosperity Fund – Allocation of funding approved.

With reference to the minutes of 30th January 2025 (Print 6, page 53) approving proposals to utilise the budget allocation available to Glasgow for the extension year (2025/26) of the UK Shared Prosperity Fund (UKSPF), following confirmation of the budget from the UK Government in October 2024, Councillor Aitken, Leader of the Council and City Convener for City and City Region Economy and Just Transition, presented a report regarding the fund, advising that

- (1) the UK Government had applied a minimum allocation for capital expenditure for the current programme and Glasgow City Region had proposed that the total regional capital allocation be split proportionately across all 8 local authorities and this meant that Glasgow had a minimum of £2,761,060 to invest in capital programmes, however £150,000 of this funding had already been approved to support businesses through the Green Business Support Grant, leaving £2,611,060 available for other capital project activity;
- (2) for the 2023-25 financial years, the allocation of capital funding was managed through an open competition and given a 1 year extension, there was a significant risk that taking a similar approach would result in projects being unable to spend the allocation within the timeframe, due to the length of time to put in place a process, conclude grant agreements and undertake delivery of the projects;
- (3) following a trawl of potential projects, officers from Neighbourhoods, Regeneration and Sustainability and Economic Development had identified The Lighthouse (Ward 10) and the Kelvinhall (Ward 10) as projects which met the criteria for funding from the UKSPF, could be delivered within the 2025/26 financial year and had been identified as having a major impact in attracting further private sector investment in the properties;
- (4) the Contracts and Property Committee on 6th February 2025 (Print 6, page 83) had authorised the Executive Director of Neighbourhoods, Regeneration and Sustainability to commence off-market negotiations with Sustainable Ventures (Scotland) Ltd of the Council owned Lighthouse which was a Category A listed sandstone building designed by Charles Rennie Mackintosh;
- (5) it was proposed that £2m of funding from the UKSPF be used to ensure that the condition of The Lighthouse building supported the proposed transformation for Sustainable Ventures (Scotland) Ltd to make it a Net Zero Innovation Hub which would create a space for Clean Tech companies in Scotland to grow, driving economic activity and supporting talent in the Glasgow City Region;
- (6) officers had been looking at the options for the long-term future of the Charles Rennie Mackintosh exhibition at The Lighthouse and consideration was being given as to whether the exhibition could continue to be accommodated within The Lighthouse or whether it would be re-interpreted at another publicly accessible venue;
- (7) following a series of successful investments in the Kelvinhall, a substantial portion of vacant floorspace remained available and officers from the Council and Glasgow Life had received expressions of interest from commercial operators to utilise the vacant floorspace;
- (8) the Kelvinhall was in need of investment to unlock it's potential and whilst the optimal use of the space was still to be determined, several interventions could be implemented to enhance its appeal and attract investment, regardless of its final purpose and it was proposed that the remaining balance of £611,060 of

- funding from the UKSPF be used for a package of internal and external measures, as detailed in the report; and
- (9) of the proposed delivery, reporting and monitoring of The Lighthouse and Kelvinhall projects.

- (a) noted the report; and
- (b) approved £2m of funding from the UK Shared Prosperity Fund for The Lighthouse project and £611,060 of funding for the Kelvinhall project, as detailed in the report.

Circular Economy Route Map for Glasgow 2025-30 approved.

- With reference to the minutes of the Net Zero and Climate Progress Monitoring City Policy Committee of 15th April 2025 (page 68 hereof) when it was agreed to recommend to this committee approval of the Circular Economy Route Map for Glasgow 2025-30, Councillor Millar, City Convener for Climate, Glasgow Green Deal, Transport and City Centre Recovery, presented a report on the matter, advising
- (1) of the review of the Circular Economy Route Map and Action Plan;
- (2) that the updated Circular Economy Route Map for 2025-30 for Glasgow, as detailed in Appendix 1 to the report;
 - (a) built on the progress to date and set out the framework for Glasgow to further progress to a sustainable future, presented a vision for a circular city and provided a set of actions to support the transition to a circular economy;
 - (b) provided the most up to date strategic context and key drivers for a circular economy in Glasgow, the climate emergency, net zero commitments and the need for the city to be a resilient, thriving economy within the local environment and planetary boundaries together with the challenges and opportunities that the transition to a circular economy presented; and
 - (c) outlined that the key focus of the Circular Economy Route Map was the updated themes and priority areas which had been identified through a Circular Economy Working Group review process and Action Plan, as detailed in the report; and
- (3) of the next steps.

- (ii) approved the updated Circular Economy Route Map for Glasgow 2025-30.

City Centre Strategy 2024-30 - Progress etc noted.

- With reference to the minutes of the City Administration Committee of 21st March 2024 (Print 1, page 42) approving the City Centre Strategy (CCS) 2024-30, there was submitted a report by the Executive Director of Neighbourhoods, Regeneration and Sustainability regarding the progress made of the strategy, advising
- (1) that the vision for the CCS 2024-30 had been developed around 3 key pillars, namely, Magnetic Experience, Front Door to Innovation and A Place to Live, as detailed in the report;
- (2) that the City Centre Task Force (CCTF) and its thematic sub-group structure were the strategic body with oversight over the CCS and was co-chaired by Councillor Millar, City Convener for Climate, Glasgow Green Deal, Transport and City Centre Recovery and Mr Stuart Patrick, Chief Executive, Glasgow Chamber of Commerce and in addition to the sub-group workplans, the CCTF

- was supported by 4 high priority actions for delivery over 2025, as detailed in the report;
- (3) of the progress made in relation to the projects within the 3 guiding pillars; and
- (4) that the city centre performance monitoring was assessed at macro level through an open dashboard which tracked a range of quantifiable indicators that provided an ongoing record on the 3 themes of people movement, tourism and employment and in addition, each priority action within the CCS would be delivering outputs and outcomes and this extensive list would be developed into a shortlist that could be reported upon in future CCS updates to this committee.

After consideration and having heard a presentation by Ms Mandy MacDonald, Neighbourhoods, Regeneration and Sustainability, the committee noted

- (a) the presentation and the report;
- (b) the progress made on the City Centre Strategy 2024-30 from November 2024 to March 2025; and
- (c) that bi-annual updates on the City Centre Strategy 2024-30 would be submitted to this committee.

Bus network workstreams - Progress and consultation noted.

- 3 There was submitted a report by the Executive Director of Neighbourhoods, Regeneration and Sustainability regarding an update on the various related workstreams in Glasgow, advising
- (1) that the Scottish Government would be launching a new Bus Infrastructure Fund (BIF) for 2025/26 which would focus on the delivery of bus priority and other bus infrastructures, with the aim of improving the attractiveness of bus services and would replace the Community Bus Fund and the Bus Partnership Fund;
- (2) that Strathclyde Partnership for Transport (SPT) had commenced a consultation on the draft Strathclyde Regional Bus Strategy (SRBS) and the aim of the strategy was to reverse the decline in bus use, increase bus attractiveness for use and ensure that buses provided essential access for everyday journeys;
- (3) that SPT had initially proposed a dual approach to tackle the bus 'cycle of decline' which would have seen a Bus Service Improvement Partnership (BSIP) formed in the short-term to deliver key activities, however, the results of SPT's consultation with stakeholders and elected officials had demonstrated that there was limited support for that approach, particularly due to the resources required to carry out the formal statutory process for a BSIP, as detailed in the report;

- of a review of the governance arrangements of the Glasgow City Regional Bus Partnership;
- (5) that officers were working with key partners and stakeholders to explore options to deliver a free public transport pilot;
- (6) of the work of the Bus Operators Co-ordination Group; and
- (7) that in December 2023, the Scottish Government budget had resulted in the withdrawal of capital funding to SPT for public transport improvements, however SPT had indicated that it was anticipated that funding would resume for 2025/26 and officers in Neighbourhoods, Regeneration and Sustainability were awaiting details of what funding would be available.

- (a) the progress of bus network related activities in Glasgow; and
- (b) the current consultation on SPT's Strathclyde Regional Bus Strategy.

Feminist Urbanism Working Group - Update noted.

- 4 There was submitted and noted a report by the Executive Director of Neighbourhoods, Regeneration and Sustainability regarding an update on the progress to implementing a Feminist City workstream, advising
- (1) that Glasgow's strategic plan 2022-27 had included a number of priorities that centred the needs and experiences of women and girls, building on previous work to empower them in line with Sustainable Development Goal 5, as detailed in the report;
- (2) that the Council on 27th October 2022 (Print 4, page 397) had approved a motion agreeing to adopt a feminist town planning approach within planning policy and the City Development plan and to adopt a similar approach to gender disaggregation of a data, gender budgeting and to ensure gender competence training key Council staff, as detailed in the report;
- (3) of the work of the Eurocities Taskforce on Women's Rights and Gender Equality which Glasgow co-chairs with Nantes, under the leadership of Vienna which included knowledge exchanges on gender sensitive planning;
- (4) that in 2023, a political oversight group was set up for officers and cross-party elected member working, to allow a forum for discussion of delivery on the aims of the feminist city, as detailed in the report;
- (5) that the working group had focused on delivering improvements to public spaces through lighting in parks and access routes within and to parks, improved play areas with girls in mind with additional improvements being

planned for active travel routes, including wayfinding in public art and these projects were being delivered by the Council from a £1m allocation of funding from the feminist action fund over 2 years:

- (6) that the engagement with women on proposed projects and policies was a focus of the delivery of the City Development Plan 2 and the engagement strategy for the plan required to consider how to engage with women more effectively, as detailed in the report;
- (7) of the Park Lighting review in relation to safety and lighting and the public toilet strategy which recognised that the provision of public toilets were a key element of a feminist city, as detailed in the report; and
- (8) of the next steps.

Bailie Wardrop noted her interest in this matter.

Glasgow's Local Housing Strategy 2023-28 - Annual review noted.

- With reference to the minutes of the City Administration Committee of 18th May 2023 (Print 2, page 29) approving Glasgow's Local Housing Strategy (LHS) 2023-28, there was submitted a report by the Executive Director of Neighbourhoods, Regeneration and Sustainability, regarding an annual review of the progress of the actions outlined in the delivery plan of Glasgow's LHS 2023-28, advising
- (1) that under the Housing (Scotland) Act 2021, local authorities were required to prepare a LHS supported by an assessment of housing need and demand;
- (2) that the LHS outlined what the Council and its partners aimed to deliver for the city during the scheduled 5-year period and Glasgow's LHS had been prepared in accordance with Scottish Government guidance;
- (3) of the 4 grand challenges which had been identified in the Council's Strategic Plan 2022-27 for the Council to deliver against and Glasgow's LHS 2023-28 had made a critical contribution to the 4 grand challenges, with a particular focus on missions to improve health and wellbeing, support inclusive, resilient and sustainable economic growth, become a net zero carbon city by 2230 and create safe, clean and thriving neighbourhoods;
- (4) of the 5 strategic priorities which had been set out in Glasgow's LHS together with the progress of the LHS delivery plan which set out 59 actions under those priorities as detailed in the report; and
- (5) of the progress of the delivery of the LHS for 2025/26, as detailed in the report.

After consideration, the committee noted the progress of actions and key issues arising as set out in Glasgow's Local Housing Strategy 2023-28 annual review report year 2 (2024/25).

Empty Homes Action Plan - Update noted etc - Instruction to officers.

- With reference to the minutes of the City Administration Committee of 18th May 2023 (Print 2, page 29) approving Glasgow's Local Housing Strategy (LHS) 2023-28, there was submitted a report by the Executive Director of Neighbourhoods, Regeneration and Sustainability regarding the progress of the empty homes action plan which had been incorporated within Glasgow's LHS 2023-28, advising
- (1) that in March 2021, the Scottish Government had published Scotland's first long-term national strategy "Housing to 2040" which included the priorities for empty homes, as detailed in the report;
- (2) that in November 2021 in response to the Scottish Government's "Housing to 2040" document, the Scottish Empty Homes Partnership in collaboration with COSLA and the Association of Local Authority Chief Housing Officers had published its paper "Why Empty Homes Matter" the aim of which was to further develop the work of local authorities on empty homes through an awareness campaign to highlight the benefits of empty homes work, as detailed in the report;
- (3) of the statistics obtained from Council Tax records across Scotland in relation to empty properties in September 2024 and that as at 28th February 2025, Council Tax records had shown that a total of 3,030 non-exempt long term empty homes in Glasgow lying empty for more than 6 months, with 1,805 being empty for more than 12 months;
- (4) of the breakdown of local term empty homes by Ward with the highest number of long-term empty properties being in Ward 10, Anderston/City/Yorkhill;
- (5) that residential priorities and empty homes had been identified as 1 of the 10 strategic and crosscutting critical success factors for delivering housing priorities outlined in the LHS and the repurposing of vacant buildings and former office accommodation for housing in the city centre was a key action within the Empty Homes Action Plan, as detailed in the report;
- (6) that the Empty Homes Team had continued to work successfully with Registered Social Landlords partners in acquiring empty flats or shops that could be converted to housing in pre-19 tenement properties in order to facilitate common repair works and enable factoring arrangements to be put in place and in addition action was also being targeted at bringing larger family homes back into use;
- (7) of the key Empty Homes Targets which had been identified in the Empty Homes Review report, as detailed in the report;
- (8) of the progress of the Empty Homes Action Plan 2023/24, as detailed in Appendix 1, to the report; and

(9) of the actions taken and the next steps.

After consideration, the committee

- (a) noted
 - (i) the report; and
 - (ii) that Glasgow's Empty Homes Action Plan had been incorporated within the Local Housing Strategy 2023-28 with an annual update on progress being submitted to this committee; and
- (b) instructed officers in Neighbourhoods, Regeneration and Sustainability to arrange another Empty Homes workshop for members of this committee in 2026.

Bantaskin Street (Ward 15) Self-build Housing Pilot – Findings of evaluation noted.

- 7 There was submitted a report by the Executive Director of Neighbourhoods, Regeneration and Sustainability regarding the progress of the Bantaskin Street (Ward 15) self-build pilot project and the findings of an evaluation of the project, advising
- (1) that the Contracts and Property Committee on 14th June 2018 (Print 2, page 136) had approved the disposal of an area of land adjacent to Bantaskin Street for a self-build pilot development located in the Maryhill Transformational Regeneration Area;
- (2) of the aims of the self-build pilot project at Bantaskin Street;
- (3) that a range of Council Services had been involved in developing a simplified procurement process, providing serviced plots with a design code and implementing a 'plot passport' approach to planning, to support the self-build developers participating in the project and a masterplan had formed part of the planning permission for the Bantaskin Street site which enabled the self-builders to design their own homes, as detailed in the report;
- (4) that following a series of information events held to assess demand and launch the development plots at the start of the project, there were over 200 households keen to self-build in Glasgow and an allocation policy was developed which was used to identify 6 self-build developers;
- (5) that the pilot project at Bantaskin Street was now at an advanced stage, with a total of 5 plots now being either complete, on site with habitation or nearing completion and soon to be occupied, delivery of one of the plots had been severely delayed with a lack of progress, however a new owner had recently purchased the plot which should lead to development in due course and the development of a community garden, funded from the Council's Vacant and

- Derelict Land Fund was still to be undertaken and the road infrastructure works needed to be completed to enable the road to be adopted;
- (6) of the outcome of an independent evaluation of the Bantaskin Street self-build housing pilot project which North Star Consulting and Research had been commissioned to undertake on behalf of the Council; and
- (7) of the next steps for the Bantaskin Street self-build housing pilot project.

- (a) the update on the delivery of the Bantaskin Street self-build housing pilot project; and
- (b) the evaluation that had been carried out in relation to the Bantaskin Street self-build housing pilot project, including associated feedback and recommendations.

Work of Glasgow Urban Design Panel noted.

- 8 There was submitted a report by the Executive Director of Neighbourhoods, Regeneration and Sustainability regarding the role and work of the Glasgow Urban Design Panel (GUDP), advising that
- (1) the GUDP was a partnership between the Council's Planning Service and the Glasgow Institute of Architects (GIA) which had been established in 2006 and was informed and structured around the Commission for Architecture and the Built Environment Design Review, Principles and Practice to be independent, expert, multidisciplinary, accountable, transparent, proportionate, timely, advisory, objective and accessible;
- the Council's Planning Service hosted and facilitated the GUDP and invited projects at their early stages of design development for review, while the GIA volunteers as the lead for secretariat and together with the Glasgow Civic Forum invited built environment experts to review proposals and to report on the panel findings, as detailed in the report;
- (3) although the views of the GUDP were not part of the statutory planning process, they were valued as having an important role in terms of independent critical analysis which can be utilised to drive design improvement and negotiate the highest possible standards by refining development proposals; and
- (4) in 2024, the GUDP had reviewed 12 proposals, with each proposal having a different degree of complexity and strategic importance for the city, as detailed in the report.

After consideration, the committee noted

- (a) the report;
- (b) the work of the Glasgow Urban Design Panel in championing placemaking and design excellence and its independent role offering critical analysis and input intended to improve the design development of planning proposals; and
- (c) that officers in Neighbourhoods, Regeneration and Sustainability would raise with the Glasgow Institute of Architects the issue of membership and gender balance on the Glasgow Urban Design Panel.

Twenty years of active schools – Update noted.

1 There was submitted a report by the Executive Director of Education Services regarding the ongoing work of the Physical Education, Physical Activity and School Sport (PEPASS) team and the impact of the continuing work of Active Schools,

(1) advising

- (a) of the make up of the PEPASS team whose aim was to provide learners with a platform from which they could build physical competences, improve aspects of fitness, and develop personal and interpersonal skills and attributes;
- (b) of the priority areas of the Active Schools programme which had now been running for 20 years and of the various Active School events that had been delivered;
- (c) of the various pathways of opportunity offered to young people from primary 6 through to sixth year and beyond in the development of the young workforce through sport;
- (d) of the highlights of the various programmes available within the programme;
- (e) of examples of partnership working to support the Active Schools programme, as detailed in the report; and
- (f) that a bespoke teaching and learning programme was delivered across selected schools which aimed to establish a sustainable model by upskilling staff with the knowledge, confidence, and skills necessary to deliver high-quality Physical Education; and
- (2) detailing in the appendices to the report, the calendar of PEPASS city events during 2024/25 and Learn to Swim Team overview for 2023/24.

After consideration, the committee noted Education Services' PEPASS work to support Physical Education and the health and wellbeing of children and young people across the city.

Education Services CREATE - Progress noted.

- With reference to the minutes of 7th March 2024 (Print 7, page 55) noting progress of Education Services' CREATE Expressive Arts Service as outlined in Standards and Quality Report 2022–2023, there was submitted and noted a report by the Executive Director of Education Services regarding further progress as outlined in Standards and Quality Report 2023-24, advising of
- (1) an overview of the CREATE staffing structure for 2024;
- (2) the various programmes that the CREATE service provided for its learners, along with the various partners involved in the programme, as detailed in the report; and
- (3) the next steps in the CREATE service.

National thematic inspection on supporting improvement – Update noted.

- There was submitted a report by the Executive Director of Education Services regarding the outcome of the national thematic inspection carried out by His Majesty's Inspectorate of Education (HMIE) on how local authorities supported improvement, advising
- (1) that HMIE had informed all local authorities in June 2024 that they would be carrying out a national thematic inspection of the role Local Authorities played in supporting schools to improve the quality of education;
- (2) of a list of the main recommendations that had been made following the visits;
- (3) of a summarised analysis of the findings in each of the 4 key areas that had been submitted by the lead inspector for each of the local authorities; and
- (4) that the national thematic inspection had given Education Services an opportunity to have an external partner scrutinise the work it was doing to support improvement in schools and how this impacted on improving outcomes for children and young people, and had resulted in a positive report which highlighted many areas of very good practice in city schools, supported organisations and strategic leaders at all levels.

After consideration, the committee noted the positive analysis of the supporting improvement work which had taken place across the Education Service.

Partner Commissioning Arrangements – Proposals agreed – Reference to City Administration Committee.

- 4 There was submitted a report by the Executive Director of Education Services regarding a proposed rate for funded providers within Early Learning and Childcare from April 2025, advising that
- (1) the Scottish Government's Funding Follows the Child Guidance and National Standard had set out the principles and practice for funded early years providers seeking to enter or maintain partnership status with a local authority;
- (2) guidance for setting sustainable rates for the delivery of funded early learning and childcare in 2025-26 had been issued in February 2025 and outlined the criteria which councils should follow in setting a sustainable rate; and
- in addition to the rate per hour all funded children were also entitled to a free meal each day the child attended as part of their statutory entitlement, which was payable daily over and above the hourly rate per child.

After consideration, the committee agreed that the report be referred to the City Administration Committee, proposing an increase to the commissioning rate to

- (a) £6.70 per child per hour from April 2025 for 3–5 year olds; and
- (b) £7.94 per child per hour from April 2025 for 2–3 year olds.

- 1 With reference to the minutes of 27th August 2024 (Print 3, page 109) noting an update on the Council's Parking Services, there was submitted and noted a report by the Executive Director of Neighbourhoods, Regeneration and Sustainability providing a further update on the activities and progress of the service, advising
- (1) of an update on Parking Services' functions in relation to enforcement of parking, bus lane and Low Emission Zone violations which played a pivotal role to ensure the functionality of the city and alignment with the objectives outlined in the Transport Strategy framework;
- (2) of the parking operations and notable achievements made by the Operations team to date, as detailed in the report;
- (3) of progress on multiple projects, along with details of several projects that were ongoing or in planning stages, as detailed in the report; and
- (4) that further updates of key parking services workstreams would continue to be reported to committee as appropriate.

Parks and Open Spaces Improvement Fund - Update noted.

There was submitted and noted a report by the Executive Director of Neighbourhoods, Regeneration and Sustainability providing an update on the status of projects funded from the Parks and Open Spaces Improvement Fund,

(1) advising

- (a) that following the allocation of £1.5m from the Council budget in 2021/22 towards a Local Parks and Open Spaces Improvement Fund for a range of improvements in local parks and open spaces, the Council had allocated a further £1.5m as part of its budget in 2022/23;
- (b) that the service had worked with colleagues in the Communities team to develop a reporting mechanism for each Area Partnership, who had set out their recommendations for their allocations, however this had meant an increase in workload of the existing teams and had resulted in a slower delivery of the funded projects than expected by the Area Partnerships;
- (c) that following a series of reports presented to Area Partnership meetings since 2024, a total of £29,388 remained unallocated to a specific programme;
- (d) of a variety of funding themes that Area Partnerships had supported in its allocations, as detailed in the report; and
- (e) of the next steps in relation to projects where delivery timescales had not yet been scheduled, as detailed in the report; and
- (2) detailing in an appendix to the report, the projects that had been approved and their current status for each Ward.

Firework Control Zone update 2025 noted.

With reference to the minutes of the City Administration Committee of 21st March 2024 (Print 1, page 45) approving the use of Firework Control Zones discretionary powers during the period around the 5th November, there was submitted and noted a report by the Executive Director of Neighbourhoods, Regeneration and Sustainability providing an update on the review of the Firework Control Zone (FCZ) process and the plans in place for 2025,

(1) advising

- (a) that during 2024, 16 FCZ applications from various areas within the city had been progressed to the consultation stage;
- (b) that following an analysis of data and intelligence, 4 applications for a FCZ in Pollokshields had been approved and due to legal requirements for a 60-day notice period prior to activation, the Pollokshields FCZ would now take effect in November 2025;
- (c) of the key measures that had been identified and implemented to enhance the effectiveness of the FCZ;

- (d) that following a motion approved by the Council on 16th May 2024 (Print 2, page 21), a citywide FCZ consultation had been carried out, with 2,692 responses received, 2,437 of them from Glasgow residents;
- (e) that it had been recognised that a citywide FCZ would not be within scope due to specific guidelines set out in the Fireworks and Pyrotechnic Articles (Scotland) Act 2022 that indicated FCZ's had not been designed as a measure to cover a whole local authority area or cover extensive parts of a local authority area;
- (f) of other measures that would be implemented by the service, in consultation with partners around the early intervention and education plans for 2025; and
- (g) of the approach for 2025 and the findings from conversations with officers in other local authorities regarding the matter, as detailed in the report; and
- (2) detailing in the appendix to the report, a timeline of key dates related to the FCZ process for 2025.

Neighbourhood Infrastructure Improvement Fund - Update noted.

- 1 With reference to the minutes 23rd May 2023 (Print 2, page 59) noting the proposed phased approach to the installation, including progress towards delivering Phase 1 of the Glasgow City Council Solar Photovoltaic (PV) Installation Programme including the available capital funding, there was submitted a report by the Executive Director of Neighbourhoods, Regeneration and Sustainability, advising
- (1) that of the 8 buildings that had been identified as part of Phase 1 of the programme, PV installation on 7 of the buildings had been completed on 29th November 2024, and installation of PV at the Kelvinhall commenced on 13th January 2025 with a proposed completion date of 23rd May 2025; and
- (2) of proposals for future phases of the PV Installation together with the next steps, as detailed in the report.

After consideration, the committee noted

- (a) the progress of Phase 1 of the solar PV installation and the revised timescale for completion;

- (1) that the updated Circular Economy Route Map for 2025-30 for Glasgow, as detailed in Appendix 1 to the report;
 - (a) built on the progress to date and set out the framework for Glasgow to further progress to a sustainable future, presented a vision for a circular city and provided a set of actions to support the transition to a circular economy;
 - (b) provided the most up to date strategic context and key drivers for a circular economy in Glasgow, the climate emergency, net zero commitments and the need for the city to be a resilient, thriving economy within the local environment and planetary boundaries together with the challenges and opportunities that the transition to a circular economy presented; and
 - (c) outlined that the key focus of the Circular Economy Route Map was the updated themes and priority areas which had been identified through the Circular Economy Working Group review process and Action Plan as detailed in the report; and

Energy Management Team update noted etc.

 - (a) the use of the EQIA guidance tool ensured that decision making was informed by the Equality Act 2010, the Public Sector Equality duty, whilst supporting the development of policy, strategy and attendant actions flowing from the Council's Equality Outcomes; and
 - (b) the guidance would be regularly updated and reviewed, as would future training sessions to ensure accessibility to a wider number of those completing the EQIA process; and
- (2) detailing in the Appendix to the report, the updated EQIA guidance, as at March 2025.

After consideration, the committee noted

- (i) the revised guidance;
- (ii) the rolling programme of training and the next steps; and
- (iii) the focus of the EQIA tool and how it scrutinised decision making.

Open Government Action Plan – Update noted.

- There was submitted and noted a report by the Chief Executive regarding the findings from the Open Government: Open Call for Ideas undertaken to inform the development of Glasgow's second Open Government Action Plan, advising of
- (1) a summary of the findings from the Open Government: Open Call for Ideas 2024, which had been undertaken with relevant stakeholders between 9th August and 26th September 2024 to inform the development of Glasgow's second Plan:
- the proposed next steps to further shape the open government commitments for inclusion within the Open Government Action Plan 2 for Glasgow 2025-2027 and its mainstreaming into the work of services and the Glasgow Community Planning Partnership (GCPP); and
- (3) that a draft Open Government Action Plan for Glasgow 2025-2027 would be submitted to this committee in September 2025 and would remain on the committee's workplan.

Gambling harms in Glasgow – Update noted.

- With reference to the minutes of 10th August 2023 (Print 3, page 71) noting an update on the multi-agency Gambling Related Harms Group and progress to embed a whole systems approach to tackle gambling harms across Glasgow, there was submitted a report by the Head of Policy and Corporate Governance providing an update on further progress, advising
- (1) that a Local Action Plan had been developed and published in March 2023 as an output of a 3-year pathfinder project funded by Public Health Scotland and had been based on continuing collaboration with third sector partners, community planning partners, academics and those with experience of gambling harms;
- of the progress of Glasgow's Whole Systems Local Action Plan and work that had been undertaken to promote awareness of gambling harms;
- of the recent learning and evidence that had been captured by the University of Glasgow Gambling Research Group who had analysed gambling from various perspectives, particularly its effect on vulnerable groups and that of Local Gambling Harms intelligence captured and reported by partners;
- (4) of the developments that had been made by both the Scottish and UK Governments in tackling gambling harms and the Scottish Government's establishment of a Working Group on Gambling Harms in October 2024 in response to advocacy efforts;

- (5) of the UK Government's response and confirmation of a Gambling Levy on 27th November 2024 and the consultation which proposed the distribution of funding split; and
- (6) of a recent rapid evidence review which had been undertaken by Gambleaware that had recommended more bespoke treatments for gambling harms and that Glasgow could be developed as a Centre of Excellence and a regional hub for a multi-agency treatment response, but this would depend on funding, treatment model options and planning that would be required across the National Health Service system and partners.

After consideration, the committee

- (a) noted the work and conveyed its support for the continued action and local levy planning to tackle gambling related harm; and
- (b) agreed
 - to continue engagement with the Scottish Government and national bodies;
 - (ii) to support that the UK Government, review the Gambling Act and ensure Glasgow was fairly funded to address gambling harms; and
 - (iii) that the Chief Executive would write to the Secretary of State for Culture, Media and Sport and the Minister for Gambling to seek funding assurance to enable a planned public health approach locally to reduce gambling harms in the city.

- With reference to the minutes of the Finance and Audit Scrutiny Committee of 11th March 2025 (Print 7, page 111) approving that a comprehensive internal review of the Council's governance arrangements relating to workforce and service reform activity was being undertaken, taking into account the findings and recommendations arising from an independent review and any recommendations put forward by the Council's external auditor, there was submitted a report by the Director of Communication and Corporate Governance regarding the proposed changes following the independent review, advising of

- (6) that across Scotland, other local authorities supported talented sports performers by operating a bursary programme which was open to residents who were participating in sport at a performance or excellence level and that

- the bursary programme was an option available to the Council and was based on the outcome of any consultation; and
- (7) of the Future of Glasgow's Talented Sportspeople consultation and that it was envisaged the consultation would take place between April and August 2025 with findings and recommendations submitted to a future meeting of the relevant committee.

Games Village Phase 2 (Ward 9) - Variation to development agreement approved etc - Authority to Director of City Development.

- With reference to the minutes of 29th August 2024 (Print 3, page 126) approving the Council varying the terms of the development agreement for the Games Village Phase 2 to allow the bulk sale of 58 units to the Places for People, Thriving Investments, MMR Fund and its nominees/subsidiaries, there was submitted a report by the Executive Director of Neighbourhoods, Regeneration and Sustainability seeking approval for a further variation, advising
- (1) that City Legacy Ltd (CLG) had approached the Council to request a further variation to the development agreement that would allow sub-leases to be granted to Cruden and CCG who were lead developers of the Phase 2 site;
- (2) that the development of Phase 2 would be split in 2 in terms of housingtenure, with CCG providing 58 units of social housing and Cruden providing 67 units of private housing which was intended to address market conditions and commercial risk;

- (4) of the terms and conditions.
