# CIVIC GOVERNMENT (SCOTLAND) ACT 1982 PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED

Purpose of Report:
To advise Members of the circumstances leading to the immediate suspension of Mr Andrew Coyle's private hire car driver's licence (PD31633).
Recommendations:
Members are asked to consider, in view of the background information and having given the licence holder an opportunity to be heard, whether to:-
(a) suspend Mr Coyle's private hire car driver's licence for the unexpired portion of its duration or such shorter period as you may determine and, if so, whether the suspension is with immediate effect; or
(b) revoke Mr Coyle's private hire car driver's licence.

#### 1 Background

- 1.1 Mr Andrew Coyle was granted the grant of his private hire car driver's licence by this Authority on 23 April 2024 for a period of three years with effect from 23 April 2024 and with an expiry date of 31 March 2027 subject to the requirement that he undergoes medical examinations in March 2025, 2026 and 2027.
- 1.2 The Licensing Section received information from People Asset Management that Mr Coyle failed to attend a recent medical examination.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Coyle's private hire car driver's licence was suspended on 4 April 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Coyle's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
