**CIVIC GOVERNMENT (SCOTLAND) ACT 1982  
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

**Purpose of Report:**

To advise Members of the circumstances leading to the immediate suspension of Mr Daniel Hughes' private hire car driver's licence (PD28553).

## 1 Background

- 1.1 Mr Daniel Hughes was granted the renewal of his private hire car driver's licence by this Authority on 24 October 2022 for a period of three years with effect from 1 December 2021 and with an expiry date of 30 November 2024 subject to the requirement that he undergoes medical examinations in December 2022 and 2023. A renewal application is currently being processed by the Licensing Section.
- 1.2 The Licensing Section received information from People Asset Management regarding Mr Hughes' fitness in terms of Group 2 standards, a copy of which will tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Hughes' private hire car driver's licence was suspended on 7 April 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Hughes' licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
