**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr William Dempster's private hire car driver's licence (PD29771).

1 Background

- 1.1 Mr William Dempster was granted the renewal of his private hire car driver's licence by this Authority on 6 May 2023 for a period of three years with effect from 1 March 2022 and with an expiry date of 28 February 2025 subject to the requirement that he undergoes medical examinations in July 2023 and 2024. A renewal application is currently being processed by the Licensing Section.
- 1.2 The Licensing Section received a report from People Asset Management advising that Mr Dempster did not attend a recent medical examination.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Dempster's private hire car driver's licence was suspended on 25 April 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Dempster's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
