IMPLEMENTATION OF CITY PLAN POLICY ENV2 /IPG QUEENS PARK PLAY AREA RENEWAL

Purpose of Report:

To seek Committee approval to allocate £87,944 of ENV2/IPG12 Childrens Play funding in support of the renewal of play facilities at Queens Park.

1. Purpose of Report

- 1.1 Members are asked to support the allocation of £87,944 of ENV2/ IPG12 Childrens Play funds towards the renewal of play facilities at Queens Park, near the Balvicar Street Entrance, to supplement funds of £113,777 which have been secured to date.
- 1.2 The total allocation comprises a **capital** sum of £70,401 towards construction works and a **revenue** sum of £17,543 which acts as a contribution towards ongoing maintenance over a 10-year period.
- 1.3 In accordance with established procedures relating to policy ENV2 these proposals were approved by the Projects Assessment Group (PAG) on 29th January 2025 and subsequent consultation took place with elected members representing Ward No's 6,7 and 8.

2. Background and Consultation

- 2.1 <u>Play Sufficiency Assessment</u> engagement with children locally identified Queens Park as a popular location for play, with a view expressed that there should be a greater quantity of play equipment across our play estate locally, and that existing equipment should be repaired or replaced, with young people suggesting lighting as a means of increasing participation and perceptions of safety.
- 2.2 It is noted that place standard workshops carried out with community and stakeholders at Queens Park for the Parks Review of Lighting noted that lighting within play areas which are close to park entrances, can increase opportunities for families to be physically active during the winter months.
- 2.3 Neighbourhoods, Regeneration & Sustainability have been engaging with Queens Park Working Group in relation to the planned refurbishment of Balvicar Street Play Area. Community Representatives, in partnership with the School of Education at University of Glasgow undertook community consultation, identifying an ambition to extend the footprint of the play area, increased seating and picnic facilities, increased toddler and accessible & inclusive equipment, and climbing structures which had platforms of different heights connected by bridges.
- 2.4 It is recommended that £70,401 of Capital from Developer Contributions is allocated to allow the following elements to be added to the project brief, in order to reflect the consultation findings set out above.
 - Increase the number of items of equipment by adding additional toddler equipment
 - Increase the number of items of equipment by adding climbing structures which had platforms of different heights connected by bridges

 In delivering the above two elements, we would be increasing the footprint of the play area and improving connectivity between the play area and the rest of the park
