**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr James McQuillan's private hire car driver's licence (PD28221).

1 Background

- 1.1 Mr James McQuillan was granted the grant of his private hire car driver's licence by this Authority on 21 July 2022 for a period of three years with effect from 1 October 2021 and with an expiry date of 30 September 2024. A renewal application is currently being processed by the licensing section.
- 1.2 The licensing section received information from People Asset Management that Mr McQuillan failed to attend recent medical examinations.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr McQuillan's private hire car driver's licence was suspended on 14 March 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr McQuillan's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
