**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Yousaf Shahzad's private hire car driver's licence (PD28221).

1 Background

- 1.1 Mr Yousaf Shahzad was granted the renewal of his private hire car driver's licence by this Authority on 12 June 2023 for a period of three years with effect from 1 June 2022 and with an expiry date of 31 May 2025 subject to the requirement that he undergoes medical examinations in April 2024 and 2025.
- 1.2 The licensing section received information from People Asset Management that Mr Shahzad failed to attend a recent medical examination.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Shahzad's private hire car driver's licence was suspended on 14 March 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Shahzad's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
