CIVIC GOVERNMENT (SCOTLAND) ACT 1982 TAXI DRIVER'S LICENCE – SUSPENDED

Purpose of Report:
To advise Members of the circumstances leading to the immediate suspension of Mr Yousaf Shahzad's taxi driver's licence (TD16807).
Recommendations:
Members are asked to consider, in view of the background information and having given the licence holder an opportunity to be heard, whether to:-
(a) suspend Mr Shahzad's taxi driver's licence for the unexpired portion of its duration or such shorter period as you may determine and, if so, whether the suspension is with immediate effect; or
(b) revoke Mr Shahzad's taxi driver's licence.

1 Background

- 1.1 Mr Yousaf Shahzad was granted the grant of his taxi driver's licence by this Authority on 28 July 2023 for a period of three years with effect from 28 July 2023 and with an expiry date of 30 June 2026.
- 1.2 The licensing section received information from People Asset Management that Mr Shahzad failed to attend a recent medical examination.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Shahzad's taxi driver's licence was suspended on 14 March 2025 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Shahzad's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
