**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Inam Ur Rehman's private hire car driver's licence (PD33618).

1 Background

- 1.1 Mr Inam Ur Rehman was granted the renewal of his private hire car driver's licence by this Authority on 21 February 2025 for a period of three years with effect from 1 December 2024 and with an expiry date of 31 December 2025.
- 1.2 The Licensing Section received a complaint from the Chief Constable, Police Scotland dated 20 March 2025 requesting that Mr Ur Rehman's private hire car driver's licence be suspended. A copy of the complaint will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Ur Rehman's private hire car driver's licence was suspended on 21 March 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Ur Rehman's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
