1 Background

- 1.1 Guthrie Taxi Service was granted the renewal of their taxi licence by this Authority on 26 November 2023 for a period of three years with effect from 1 May 2023 and with an expiry date of 30 April 2026.
- 1.2 Members will recall, at its meeting of 27 August 2025, that vehicle registration LM59VKC did not comply with this authority's LEZ policy. Following submissions from Mr Cowe at that meeting, members decided to suspend the taxi licence held by Guthrie Taxi Service for the unexpired portion of its duration, with immediate effect.
- 1.3 Guthrie Taxi Service submitted an application to replace this vehicle with another and that vehicle was presented for inspection and passed that inspection on 4 September 2025. Guthrie Taxi Service have provided copies of the inspection pass certificate and certificate of insurance for the vehicle and have requested that the suspension order imposed on their taxi licence is recalled.
