## Minutes of previous meeting approved.

1 The minutes of 11th June 2024 were submitted and approved.

#### Programme for Government Flexibility – Proposals approved etc.

- There was submitted a joint report by the Programme Director, Whole Family Wellbeing & Child Poverty and Strategic Lead (Financial Inclusion & Innovation) providing an overview of the work which had been undertaken over the course of the last year to identify and progress opportunities in relation to funding flexibility,
- (1) advising
  - (a) that this was one of the central workstreams of the Child Poverty
    Programme and was pivotal to securing the system changes necessary
    to ensure sustainable and preventative services going forward;
  - (b) that the Child Poverty Programme outlined the need to re-imagine the current approach to tackling child poverty in the city and set out a number of enabling conditions that must be met in order to deliver on the necessary systemic change that included policy alignment, funding flexibility and shared accountability;
  - (c) of the background to funding flexibility which had been identified through the Child Poverty Pathfinder phase, and that through

conversations with the Scottish Government work had been undertaken to test out the scope for flexibility across a number of relevant policy areas that received funding to operate to their own specific vision and outcomes, but with a focus within child poverty, and with the intention to create an aligned funding pot that would underpin a shared ambition to tackle child poverty;

- (d) that Glasgow and Clackmannanshire have been identified as the local authorities most ready to test how to deliver on pooling budgets and streamlining reporting requirements; and
- (e) of the next steps; and
- (2) detailing in the Appendix to the report, progress made by Partners towards the development of a new Community Planning Partnership Performance Framework for Glasgow, with a view to its first version being made available in Spring 2025.

After consideration, the Partnership

- (i) noted the report;
- (ii) agreed to continue to align the Partnership's work in the city, and with the Scottish Government, to fulfil the aspirations of the Programme for Government; and
- (iii) endorsed and supported the continued development of partnership governance to drive public service reform through this work.

- (5) of the current membership of the Strategic Partnership, as detailed in the report.
