**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr James Johnston's private hire car driver's licence (PD28455).

1 Background

- 1.1 Mr James Johnston was granted the renewal of his private hire car driver's licence by this Authority on 14 October 2022 for a period of three years with effect from 1 December 2021 and with an expiry date of 30 November 2024 subject to the requirement that he undergoes medical examinations during the month of December 2022 and 2023. A renewal application is currently being processed by the Licensing Section.
- 1.2 The Licensing Section received a report from People Asset Management dated 30 January 2025 regarding Mr Johnston's fitness in terms of Group 2 standards, a copy of which will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Johnston's private hire car driver's licence was suspended on 6 December 2024 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Johnston's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
