PRIVATE HIRE CAR DRIVER'S LICENCÉ – SUSPENDED
Purpose of Report:
To advise Members of the circumstances leading to the immediate suspension of Mr Alexander Mahon's private hire car driver's licence (PD28521).

1 Background

- 1.1 Mr Alexander Mahon was granted the renewal of his private hire car driver's licence by this Authority on 18 October 2022 for a period of three years with effect from 1 December 2021 and with an expiry date of 30 November 2024. A renewal application is currently being processed by the Licensing Section.
- 1.2 The Licensing Section received a report from People Asset Management dated 29 January 2025 regarding Mr Mahon's fitness in terms of Group 2 standards, a copy of which will tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Mahon's private hire car driver's licence was suspended on 12 May 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Mahon's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
