**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

To advise Members of the circumstances leading to the immediate suspension of Mr Shahzada Durrani's private hire car driver's licence (PD33296).

1 Background

- 1.1 Mr Shahzada Durrani was granted the renewal of his private hire car driver's licence by this Authority on 17 February 2025 for a period of three years with effect from 1 November 2024 and with an expiry date of 31 October 2027.
- 1.2 The Licensing Section received information from Mr Durrani advising of a change in his medical condition.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Durrani's private hire car driver's licence was suspended on 9 May 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Durrani's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
