CIVIC GOVERNMENT (SCOTLAND) ACT 1982 PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Walid Edian's private hire car driver's licence (PD33888).

1 Background

- 1.1 Mr Walid Edian was granted the renewal of his private hire car driver's licence by this Authority on 13 March 2025 for a period of three years with effect from 1 February 2025 and with an expiry date of 31 January 2028.
- 1.2 The Licensing Section received a complaint from police Scotland, a copy of which will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Edian's private hire car driver's licence was suspended on 7 May 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Edian's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
