**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
TAXI DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Gurcharan Sidhu's taxi driver's licence (TD17369).

1 Background

- 1.1 Mr Gurcharan Sidhu was granted the renewal of his taxi driver's licence by this Authority on 13 June 2024 for a period of three years with effect from 1 May 2024 and with an expiry date of 30 April 2027 subject to the requirement that he undergoes medical examinations during the month of May 2025 and 2026.
- 1.2 The Licensing Section received information from Mr Sidhu advising of a change in his medical condition.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Sidhu's taxi driver's licence was suspended on 7 May 2025 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Sidhu's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
