**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Dalbir Singh's private hire car licence (PV24087).

1 Background

- 1.1 Mr Dalbir Singh was granted the grant of his private hire car licence by this Authority on 19 March 2024 for a period of three years with effect from 19 March 2024 and with an expiry date of 28 February 2027.
- 1.2 The Licensing Section received a complaint from the Chief Constable, Police Scotland dated 5 May 2025 requesting that Mr Singh's private hire car licence be suspended. A copy of the complaint will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Singh's private hire car licence was suspended on 12 May 2025 with immediate effect for a period of six weeks, since it was deemed that the continued operation of his private hire would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Singh's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
