1 Background

- 1.1 Dunrolynn was granted the renewal of their taxi licence by this authority on 27 July 2024 for a period of three years with effect from 1 April 2024 and with an expiry date of 31 March 2027.
- 1.2 Members may recall that the taxi vehicle failed to comply with the Council's LEZ policy and the matter was referred to this Committee for consideration at its meeting on 27 August 2025. Having heard submissions, members suspended the taxi licence for the unexpired period of its duration, with immediate effect.
- 1.3 Mr Cowe lodged an application to substitute the non-compliant vehicle with another vehicle which passed inspection on 25 September 2025. Mr Cowe has requested that the suspension order imposed on the taxi licence is recalled.
