CIVIC GOVERNMENT (SCOTLAND) ACT 1982 PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED

1 Background

- 1.1 Mr Mohammad Sarwar was granted the renewal of his private hire car driver's licence by this Authority on 20 June 2025 for a period of three years with effect from 1 June 2025 and with an expiry date of 31 May 2028 subject to undergoing medical examinations during August 2025, 2026 and 2027.
- 1.2 The Licensing Section received complaints from the Chief Constable, Police Scotland dated 9 October 2025 requesting that Mr Sarwar's private hire car driver's licence be suspended. A copy of the complaint will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Sarwar's private hire car driver's licence was suspended on 10 October 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Sarwar's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
