CIVIC GOVERNMENT (SCOTLAND) ACT 1982 TAXI DRIVER'S LICENCE – SUSPENDED

Purpose of Report:
To advise Members of the circumstances leading to the immediate suspension of Mr Joseph Fisher's taxi driver's licence (TD17934).

(a) suspend Mr Fisher's taxi driver's licence for the unexpired portion of its duration or such shorter period as you may determine and, if so, whether the suspension is with immediate effect; or
(b) revoke Mr Fisher's taxi driver's licence.

1 Background

- 1.1 Mr Joseph Fisher was granted the renewal of his taxi driver's licence by this Authority on 6 June 2025 for a period of three years with effect from 1 April 2025 and with an expiry date of 31 March 2028 subject to attending medical examinations during November 2025, 2025 and 2027.
- 1.2 The Licensing Section received information from Mr Fisher advising of a change in his medical condition.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Fisher's taxi driver's licence was suspended on 10 October 2025 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Fisher's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
