**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Stephen Doyle's private hire car driver's licence (PD32119).

1 Background

- 1.1 Mr Stephen Doyle was granted the renewal of his private hire car driver's licence by this Authority on 2 May 2024 for a period of three years with effect from 1 March 2024 and with an expiry date of 28 February 2027 subject to the requirement that he attends medical examinations during the month of September 2024, 2025 and 2026.
- 1.2 The Licensing Section received a report from People Asset Management dated 31 October 2025 regarding Mr Doyle's fitness in terms of Group 2 standards, a copy of which will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Doyle's private hire car driver's licence was suspended on 7 November 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Doyle's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
