AREA BUDGET 2025/26: APPLICATIONS FOR FUNDING

Purpose of Report:

To provide the Area Partnership with details of the current position of the 2025/26 Area Budget; inform members of applications considered under Delegated Functions; and make recommendations on further applications for funding.

Introduction.

1. This report provides details on the Area Partnership's budget position for 2025/26; any applications considered under Delegated Functions; and makes recommendations on further funding applications.

Background.

- 2. Glasgow City Council agreed its budget for 2025/26 on 13th February 2025 with the overall funding available for Area Partnerships maintained at 2024/25 levels. The City Administration Committee approved allocations to Area Partnership on 13th March 2025. The Victoria Park Area Budget for 2025/26 is £59,733.00.
- 3. The Victoria Park Area Partnership has committed a total of £36,386.00 (60.9%) to various projects. Out of this, a total of £4,218 has been committed under the Scheme of Delegated Functions, leaving a balance of £23,347.00(39.1%) yet to be allocated from the 2025/2026 Area Budget.

Applications dealt with under Delegated Functions.

4. No applications have been dealt with since the last meeting of the Area Partnership under Delegated Functions.
