Climate Plan Consultation

Background:

This revision of Glasgow's Climate Plan 2026 - 2030 builds on what has already been accomplished in the city and aims to drive us as close to net zero carbon as possible by 2030. We know the scale of opportunity in Glasgow to pursue lower-carbon energy, heating and transport - and it's more important than ever that we maintain our ambition and redouble our efforts to spur on that transition.

We believe that this revised plan will help ensure our city is better equipped to make the journey to net zero and deal with the increasing risks posed by the climate emergency. We also hope that this updated plan provides an opportunity to deliver added benefits such as warmer homes, cleaner air and green job opportunities while helping to lift families out of poverty.
