

**CARDONALD AREA PARTNERSHIP.**

Minutes of meeting held on 19th November 2024, Turf Neighbourhood Hub, Glasgow.

**Appointment of substitute approved.**

1 In terms of paragraph 6.10 of the Governance Framework, the Partnership noted that in the absence of the representative and the substitute representative from Police Scotland, the Chair had approved the attendance of Sergeant Martin Madden.

**Minutes of previous meeting approved.**

2 The minutes of 17th September 2024 were submitted and approved subject to noting that at Item 7 (4) Neighbourhood Infrastructure Fund it should read all additional festive lighting funding will be deducted from the NIF fund and none from the Area Partnership budget.

**Glasgow Community Planning Partnership Governance Framework – Membership noted.**

3 There was submitted and noted a report by the Director of Legal and Administration providing an update regarding membership of this Partnership, advising that

- (1) Gail Sheridan was no longer the representative for South Cardonald and Rosshall Community Council and the position was now vacant; and
- (2) Sheena Haffie had been nominated as the substitute member for Mossspark and Corkerhill Community Council.

## **Community Planning Partnership – Governance Framework - Register of Interests noted.**

**4** There was submitted and noted a report by the Director of Legal and Administration advising the Partnership of the requirements in relation to the Community Planning Partnership Governance Framework regarding the registration and declaration of members' interests and detailing those interests which had been declared by members of the Partnership, as detailed in an appendix to the report.

## **Police Scotland ward update noted.**

**5** There was heard a report by Sergeant Martin Madden, Police Scotland, advising the Partnership

- (1) that Inspector Jim Friel was the new inspector for local problem solving;
- (2) of the issues of fireworks in the Rosshall area; and
- (3) that Police Scotland had been attending local monthly housing meetings where intelligence and information was provided, and problem tenants highlighted.

After consideration, the Partnership noted

- (a) the report and thanked Sergeant Madden for the update and thanked Police Scotland for the work carried out within the ward; and
- (b) the concerns regarding fireworks in the ward and the lack of enforcement at the car free zone at Lourdes Primary School.

## **Scottish Fire and Rescue Service ward update noted.**

**6** There was submitted and noted a report by the Scottish Fire and Rescue Service (SFRS) regarding the current issues, incidents and work being carried out in the ward for Quarter 1, from 1st July to 30th September 2024 advising the Partnership that

- (1) the Service had attended 950 incidents in the South area, these being 309 fires, 176 special service incidents and 465 false alarms;
- (2) there had been an increase in the number of fires attended during Q2 2024/25 however the figure remained below the 5 year figure; and
- (3) the changes to Unwanted Fire Alarm Signals (UFAS), response from 1st July 2023 had seen a significant reduction in the number of false alarm incidents attended by operational crews.

## **Glasgow City Health and Social Care Partnership - Update noted etc.**

**7** There was heard a report by Daniel Maher, Glasgow City Health and Social Care Partnership (HSCP) regarding an update on the HSCP, advising that

- (1) the Quit Your Way to Stop Smoking Service remained positive and busy;
- (2) the Glasgow City Quit Your Way Team continued to pilot the use of an app to support clients who wished to stop smoking; and
- (3) in December 2024 Pat Togher would be joining as new Chief Officer.

After consideration, the Partnership

- (1) noted the report and thanked Daniel Maher for the update; and
- (2) raised a number of points and questions that were addressed by Daniel Maher.

## **Health and Social Care Partnership – Adult Health and Wellbeing Survey 2022/23 - South Glasgow update noted.**

**8** There was heard and noted a report and presentation by Daniel Maher, Glasgow City Health and Social Care Partnership regarding an update on NHS Greater Glasgow and Clyde, Adult Health and Wellbeing Survey 2022/23, advising of the South locality findings, advising that

- (1) the sample size was 1,678 residents from the South area;
- (2) the survey content included financial wellbeing, social health, social capital, health behaviours and health and fitness;
- (3) 18% of people lived alone and 41% of people aged 75+ lived alone;
- (4) 69% had a positive view of the adequacy of their household income;
- (5) 1 in 5 felt isolated from family and friends and 79% felt they belonged to their local area;
- (6) 73% valued local friendships and 83% had a positive view of social support;
- (7) 20% were current smokers and 12% of non-smokers were exposed to smoke at home or someone else's home; and
- (8) 63% of those who drank alcohol had binge drank in the last year.

**Festive Lighting 2024/25 update noted – Funding approved – Request to Executive Director of Neighbourhoods, Regeneration and Sustainability.**

9 With reference to the minutes of 17th September 2024, there was submitted a report by the Executive Director of Neighbourhoods, Regeneration and Sustainability (NRS), regarding festive lighting within the Ward, advising of

- (1) the central funding of £3,600 available to meet the costs of erecting and maintaining festive lighting and the proposed costs and locations;
- (2) the new pricing guidelines for the 2024/25 festive lighting programme; and
- (3) the festive lighting programme delivered in the Ward for 2023/24.

After consideration, the Partnership

- (a) noted the lighting arrangements and central funding available for the 2024/25 programme;
- (b) approved funding for festive lighting at the following locations at a total cost of £20,350 from the NIF fund;
  - (i) Cardonald Library;
  - (ii) Berryknowes Road;
  - (iii) Paisley Road West (on road);
  - (iv) Paisley Road West (Aldi);
  - (v) Paisley Road West (Crookston Road – boundary);
  - (vi) Mossspark Drive Community Corner; and
  - (vii) Nazareth House.
- (c) requested that Stephen Blanchflower attends the next Area Partnership meeting on 15th February 2025, and that NRS conducted a feasibility study to have festoon/garland lighting in the ward for 2025 onwards; and
- (d) if the lighting was not maintained in the ward the Partnership would be seeking a discount in the future.

**Neighbourhood Infrastructure Fund – Progress update noted – Request to Executive Director of Neighbourhoods, Regeneration and Sustainability.**

**10** There was heard a report by the Executive Director of Neighbourhoods, Regeneration and Sustainability (NRS), regarding the Cardonald Neighbourhood Infrastructure Fund (NIF).

After consideration, the Partnership

(1) noted

- (a) that a report would be presented at the next Area Partnership meeting;
- (b) that future requests for NIF proposals should be submitted to the Area Partnership to agree if costing of the proposals should be undertaken by NRS and that these would be brought back to the Area Partnership for consideration;
- (c) the concerns and frustrations regarding the lack of progress and timescales with costings; and
- (d) that Dennis Donnelly Park and bowling clubs roofs did not meet the NIF fund criteria;

(2) requested the Executive Director NRS to :-

- (a) provide a full cost breakdown of the £52,958.98 quote for the CCTV to be installed at Sandwood Primary School and Cardonald Primary School;
- (b) confirm who would be undertaking the floodlighting works at Nethercraigs pitches and full costings at the next meeting;
- (c) provide a full detailed cost breakdown of the £100,000 quote for the paths and benches at Mossbank Boulevard play park;
- (d) arrange a meeting with the Partnership in relation to NIF funding for nursery schools;
- (e) provide costings for stairs and pathway at Hartlaw Crescent; and
- (f) provide options for Nethercraig Skate Park and this to be added to the Agenda at the next meeting.

(3) approved £39,000 for 3 community murals, Phase 2 in the ward.

**Area Budget 2024/25 - Applications for funding dealt with etc.**

**11** With reference to the minutes of the Council's City Administration Committee of 21st March 2024, when the committee approved the 2024/25 Area Budget allocations, there was submitted a report by the Head of Policy and Corporate Governance advising

- (1) of the current position in relation to the Area Partnership's budget for 2024/25 that the Cardonald Area Partnership's Budget allocation for 2024/25 was £67,115.22;
- (2) that £55,804.21 had been allocated to date, including £3,007.99 under the scheme of delegated functions leaving a balance of £11,311.01;
- (3) of the applications for funding from the Area Budget for 2024/25.

After consideration, the Partnership

- (a) noted
  - (i) the position regarding the Area Budget allocation for 2024/25; and
  - (ii) the applications dealt with under delegated functions, as detailed in the report; and
- (b) dealt with applications for funding as follows, the grant awards being subject to the conditions detailed in the report:
