# CIVIC GOVERNMENT (SCOTLAND) ACT 1982 PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED

Purpose of Report:
To advise Members of the circumstances leading to the immediate suspension of Mr Paul Leebody's private hire car driver's licence (PD28185).
Recommendations:
Members are asked to consider, in view of the background information and having given the licence holder an opportunity to be heard, whether to:-
(a) suspend Mr Leebody's private hire car driver's licence for the unexpired portion of its duration or such shorter period as you may determine and, if so, whether the suspension is with immediate effect; or
(b) revoke Mr Leebody's private hire car driver's licence.

#### 1 Background

- 1.1 Mr Paul Leebody was granted the renewal of his private hire car driver's licence by this Authority on 4 July 2022 for a period of three years with effect from 1 September 2021 and with an expiry date of 31 August 2024. A renewal application is currently being processed by the Licensing Section.
- 1.2 The Licensing Section received a report from People Asset Management dated 4 December 2024 regarding Mr Leebody's fitness in terms of Group 2 standards, a copy of which will tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Leebody's private hire car driver's licence was suspended on 6 December 2024 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Leebody's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
