CIVIC GOVERNMENT (SCOTLAND) ACT 1982 PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Henry Gillespie's private hire car driver's licence (PD28365).

1 Background

- 1.1 Mr Henry Gillespie was granted the grant of his private hire car driver's licence by this Authority on 2 March 2022 for a period of three years with effect from 2 March 2022 and with an expiry date of 28 February 2025 subject to the requirement that he undergoes medical examinations during the month of February 2023 and February 2024.
- 1.2 The Licensing Section received a report from People Asset Management advising that Mr Gillespie did not attend recent medical examinations.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Gillespie's private hire car driver's licence was suspended on 6 December 2024 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Gillespie's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
