CIVIC GOVERNMENT (SCOTLAND) ACT 1982 PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Mohamed Alfatih Mohamed's private hire car driver's licence (PD31308).

Recommendations:

1 Background

- 1.1 Mr Mohamed Alfatih Mohamed was granted the grant of his private hire car driver's licence by this Authority on 5 December 2023 for a period of three years with effect from 5 December 2023 and with an expiry date of 30 November 2026.
- 1.2 The Licensing Section received a complaint from the Chief Constable, Police Scotland dated 20 December 2024 requesting that Mr Mohamed's private hire car driver's licence be suspended. A copy of the complaint will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Mohamed's private hire car driver's licence was suspended on 20 December 2024 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Mohamed's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
