**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Stewart MacAuley's private hire car driver's licence (PD29442).

Recommendations:

Members are asked to consider, in view of the background information and having given the licence holder an opportunity to be heard, whether to:-

- (a) suspend Mr MacAuley's private hire car driver's licence for the unexpired portion of its duration or such shorter period as you may determine and, if so, whether the suspension is with immediate effect; or

1 Background

- 1.1 Mr Stewart MacAuley was granted the grant of his private hire car driver's licence by this Authority on 1 December 2022 for a period of three years with effect from 1 December 2022 and with an expiry date of 30 November 2025.
- 1.2 The Licensing Section received a complaint from the Chief Constable, Police Scotland dated 29 October 2024 requesting that Mr MacAuley's private hire car driver's licence be suspended. A copy of the complaint will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr MacAuley's private hire car driver's licence was suspended on 21 November 2024 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 The complaint was scheduled to be considered by Members at its meeting on 27 November 2024 however due to an administrative oversight, the complaint was omitted from the agenda and Mr MacAuley's private hire car driver's licence was further suspended with immediate effect on 11 December 2024.
- 1.5 Members will be aware that following the immediate suspension of Mr MacAuley's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
