CIVIC GOVERNMENT (SCOTLAND) ACT 1982 PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Paul McFarlane's private hire car driver's licence (PD29269).

1 Background

- 1.1 Mr Paul McFarlane was granted the renewal of his private hire car driver's licence by this Authority on 27 June 2023 for a period of three years with effect from 1 September 2022 and with an expiry date of 31 August 2025 subject to the requirement that he undergoes a medical examination during the month of October 2024.
- 1.2 The Licensing Section received a report from People Asset Management dated 12 December 2024 regarding Mr McFarlane's fitness in terms of Group 2 standards, a copy of which will be tabled at the meeting
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr McFarlane's private hire car driver's licence was suspended on 17 December 2024 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr McFarlane's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
