**CIVIC GOVERNMENT (SCOTLAND) ACT 1982  
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

**Purpose of Report:**

To advise Members of the circumstances leading to the immediate suspension of Mr Thomas Winters' private hire car driver's licence (PD32613).

## 1 Background

- 1.1 Mr Thomas Winters was granted the grant of his private hire car driver's licence by this Authority on 12 June 2024 for a period of three years with effect from 12 June 2024 and with an expiry date of 31 May 2027.
- 1.2 The Licensing Section received a complaint from the Chief Constable, Police Scotland dated 23 December 2024 requesting that Mr Winters' private hire car driver's licence be suspended. A copy of the complaint will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Winters' private hire car driver's licence was suspended on 23 December 2024 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Winters' licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
