CIVIC GOVERNMENT (SCOTLAND) ACT 1982 TAXI DRIVER'S LICENCE – SUSPENDED

1 Background

- 1.1 Mr James McGaughey was granted the renewal of his taxi driver's licence by this Authority on 18 August 2023 for a period of three years with effect from 1 June 2023 and with an expiry date of 31 May 2026.
- 1.2 The Licensing Section received correspondence from Mr McGaughey advising of a change to his medical condition.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr McGaughey's taxi driver's licence was suspended on 20 December 2024 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr McGaughey's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
