CIVIC GOVERNMENT (SCOTLAND) ACT 1982 TAXI DRIVER'S LICENCE – SUSPENDED

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Peter Lewis' taxi driver's licence (TD16870).

1 Background

- 1.1 Mr Peter Lewis was granted the grant of his taxi driver's licence by this Authority on 8 November 2023 for a period of three years with effect from 8 November 2023 and with an expiry date of 31 October 2026 subject to the requirement that he undergoes medical examinations in the month of October 2024, 2025 and 2026.
- 1.2 The Licensing Section received a report from People Asset Management dated 2 December 2024 regarding Mr Lewis' fitness in terms of Group 2 standards, a copy of which will tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Lewis' taxi driver's licence was suspended on 6 December 2024 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Lewis' licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
