CIVIC GOVERNMENT (SCOTLAND) ACT 1982 TAXI DRIVER'S LICENCE – SUSPENDED

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Gerald Kilty's taxi driver's licence (TD16316).

1 Background

- 1.1 Mr Gerald Kilty was granted the renewal of his taxi driver's licence by this Authority on 1 May 2023 for a period of three years with effect from 1 May 2022 and with an expiry date of 30 April 2025 subject to the requirement that he undergoes medical examinations as required.
- 1.2 The Licensing Section received a report from People Asset Management advising that Mr Kilty did not attend recent medical examinations.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Kilty's taxi driver's licence was suspended on 23 December 2024 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Kilty's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
