## CIVIC GOVERNMENT (SCOTLAND) ACT 1982 TAXI DRIVER'S LICENCE – SUSPENDED

# Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Richard McKnight's taxi driver's licence (TD16200).

# **Recommendations:**

Members are asked to consider, in view of the background information and having given the licence holder an opportunity to be heard, whether to:-

- (a) suspend Mr McKnight's taxi driver's licence for the unexpired portion of its duration or such shorter period as you may determine and, if so, whether the suspension is with immediate effect; or
- (b) revoke Mr McKnight's taxi driver's licence.

### 1 Background

- 1.1 Mr Richard McKnight was granted the renewal of his taxi driver's licence by this Authority on 8 February 2023 for a period of three years with effect from 1 February 2022 and with an expiry date of 31 January 2025 subject to the requirement that he undergoes medical examinations as required.
- 1.2 The Licensing Section received a report from People Asset Management advising that Mr McKnight did not attend a recent medical examination.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr McKnight's taxi driver's licence was suspended on 17 November 2024 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Due to the Council recess over the Festive period, Mr McKnight's suspension was not able to be considered by Members and Mr McKnight's taxi driver's licence was further suspended with immediate effect on 30 December 2024.
- 1.5 Members will be aware that following the immediate suspension of Mr McKnight's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
