Local Parks and Open Spaces Update

Purpose of Report:

To provide the Area Partnership with an update on the Local Parks and Open Space Fund.

Recommendations:

The Area Partnership is asked to note the contents of this report and approve the recommendations

1. Introduction and progress to date

- 1.1 Glasgow City Council allocated £3 million to Area Partnerships across the city for investment in Parks and Open Spaces over 2021/22 & 2022/23. This report is to provide members an update on each allocated project within the ward and to advise on any further steps to be taken.
- 1.2 It should be noted that 328 projects have been approved on an ongoing basis since year 1 of this fund. Whilst the Service is placing focus on delivering these within desired timescales, these will be subject to resource pressures within the Service, alongside daily operational requirements. Where possible, the Service has been engaging with partners to grant award monies for project delivery where appropriate, to support community empowerment and local capacity building.

2. Knightswood Park Pond

- 2.1 Following earlier works the department continues to monitor water levels and wildlife welfare matters at this location. Water levels continue to be maintained at the level of the overflow, i.e. in or near their expected maximum. We'll continue monitoring water levels and wildlife welfare and retain the measuring gauge in place to assist us in this activity. We would expect water levels to drop slightly over summer months due to a reduction in rainfall and an increase in evaporation.

3. Parks and Open Spaces Fund
