**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr John Kirkwood's private hire car driver's licence (PD31675).

1 Background

- 1.1 Mr John Kirkwood was granted the renewal of his private hire car driver's licence by this Authority on 16 April 2024 for a period of three years with effect from 1 January 2024 and with an expiry date of 31 December 2026 subject to the requirement that he attends medical examinations during the month of April 2025 and 2026.
- 1.2 The Licensing Section received a recent report from People Asset Management regarding Mr Kirkwood's fitness in terms of Group 2 standards, a copy of which will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Kirkwood's private hire car driver's licence was suspended on 2 December 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 As there was no meeting of this Committee during the Council recess, Mr Kirkwood's licence was further suspended with immediate effect on 12 January 2026.
- 1.5 Members will be aware that following the immediate suspension of Mr Kirkwood's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
