**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
TAXI DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Steven Hamilton's taxi driver's licence (TD16409).

1 Background

- 1.1 Mr Steven Hamilton was granted the renewal of his taxi driver's licence by this Authority on 22 March 2023 for a period of three years with effect from 1 October 2022 and with an expiry date of 30 September 2025 subject to the requirement that he undergoes a medical examination during the month of April 2025.
- 1.2 The Licensing Section received information from Mr Hamilton advising of a change in his medical condition.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Hamilton's taxi driver's licence was suspended on 8 August 2025 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Hamilton's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
