## AWARD OF THE FRAMEWORK TENDER FOR SHARED LIVES SERVICES GCC006118SW

#### **Purpose of Report:**

- 1) To advise Contracts and Property Committee of the outcome of the tender for Shared Lives Services.
- 2) To seek Contracts and Property Committee approval for the award of a Framework Contract as outlined in Section 2.3 of this report.

#### Recommendations:

Committee is asked to:

- a) Approve the award of a Framework Agreement for Shared Lives Services as detailed within Section 2.3 of this report, for a period of five years from 16<sup>th</sup> September 2025 with an option to extend for a further period of two years; and
- b) Note that continuance of contractual arrangements will be subject to satisfactory service review outcomes being achieved.

#### 1 Background to Tender

- 1.1 The Council has purchased Shared Lives Placements for adults with disabilities for over 25 years, developing the service model as part of the support options available to adults with learning disabilities.
- 1.2 The service historically focused on learning disability as its core care group however the focus of this framework will be to support people with a broader spectrum of care needs. This includes people with a learning disability, physical disability, autism spectrum disorder, mental health difficulty, and young adults in transition from children's services to adult services with any of the needs identified above or any combinations of these. Care will be focused on enablement and skills development to enable the individual to maximize their potential to live as independently as possible.
- 1.3 The principal drivers for the Council's commitment to Shared Lives include the Social Care (Self-directed Support) (Scotland) Act 2013, the Keys to Life Learning Disability Scotland Strategy, and the Integrated Children and Young People's Services Plan. Locally, the service is consistent with the Glasgow City Health and Social Care Partnership's approach to Maximising Independence.
- 1.4 The Council intended to form a ranked multi-lot, multi supplier Framework with Shared Lives Providers to ensure the ongoing delivery of these services, with anticipated outputs estimated at up to five (5) new placements overall across the Framework as a minimum each year for the initial agreement term, and the option for this to grow further if the extension period is utilised. The Council would wish to proceed with the award of the Framework Agreement despite not achieving its aim of having multiple suppliers on the Framework.
- 1.5 The service will offer flexible support options across two tied lots. Bidders were required to bid for both Lot 1 and Lot 2 to be eligible to apply to this Framework.
  - Lot 1 Long-term Placements (Age 18+)
  - Lot 2 Respite Placements (Age 16+)
- 1.6 The tender opportunity was advertised on Public Contracts Scotland and Public Contracts Scotland Tender and UK Find a Tender on 18<sup>th</sup> April 2025 for an initial contract term of five years with an option to extend for a period of up to a further two years with a total advertised contract value of £5,421,300. This framework will replace the current framework at its expiry on 15<sup>th</sup> September 2025.

#### 2 Evaluation

2.1 There were two bids received for this Tender. One bid failed to meet the required criteria as a result of an incomplete submission and in line with the Invitation To Tender was disqualified from the tender process prior to the evaluation process commencing (Appendix 1).

- 2.2 The tender evaluation was based on identifying the Most Economically Advantageous Tender based on 60% Quality and 40% Price split. The Quality evaluation comprised of generic questions including Fair Work First and included a Lot specific case study (Lot 1) and Lot specific question (Lot 2).
- 2.3 The Successful Bidder for the Tied Lots (1 & 2) is:

The contract includes a requirement that the Provider's staff, recruitment initiatives and training arrangements demonstrate an understanding of and a commitment to the above.

Fair Work First was included as part of the quality evaluation with a weighting of 5%.

As part of the tender submission bidders were required to indicate the Community Benefits being offered should spend reach the values outlined at various thresholds across the contract. Community Benefit themes were Recruitment and Employment, Skills and Training, Supply Chain Development and Community Engagement.

The Provider being recommended for award to this framework has offered a range of community benefits including; Work place mentoring, one new Full Time Support Worker, work experience placements and community support through matching of needs through the Community Benefit Hub and Wish List.
