## CIVIC GOVERNMENT (SCOTLAND) ACT 1982 TAXI DRIVER'S LICENCE – SUSPENDED

Purpose of Report:
To advise Members of the circumstances leading to the immediate suspension of Ms Patricia Young's taxi driver's licence (TD16575).

#### 1 Background

- 1.1 Ms Patricia Young was granted the grant of her taxi driver's licence by this Authority on 11 May 2023 for a period of three years with effect from 11 May 2023 and with an expiry date of 30 April 2026.
- 1.2 The Licensing Section received a report from People Asset Management dated 26 June 2025 regarding Ms Young's fitness in terms of Group 2 standards, a copy of which will tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Ms Young's taxi driver's licence was suspended on 30 June 2025 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Ms Young's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
