GOVERNANCE FRAMEWORK: MEMBERSHIP

Purpose of report

The purpose of this report is to update members on the current membership of the Calton Area Partnership.

1. Background

- 1.1 At the meeting of the Executive Committee on 28th August 2014 the Governance Framework for the revised community planning structures was approved.

2. Calton Community Council

- 2.1 Calton Community Council was suspended for an initial period of 3 months on 12th June 2019 due to ongoing Governance issues, primarily being unable to conform to the Scheme of Governance.
- 2.2 The members have been advised that any structures that they have been nominated to attend (e.g. Area Partnership meetings) have been advised of the suspension and no official notifications (e.g. Planning & Licensing applications; Police Reports, etc.) will be received or be able to be requested in an official capacity.
- 2.3 The status of Calton Community Council has reverted to that of a Steering Committee and will meet privately week commencing 12th August 2019 to begin attempts to resolve the many issues and therefore demonstrate that they can conform to the Governance Scheme before any change to their status is agreed.

3. Third Sector

- 3.1 VSNEG had requested representatives for the North East and have identified new Third Sector representatives for the Calton Area Partnership, detailed in the table below.
