AREA PARTNERSHIP GOVERNANCE: MEMBERSHIP

Purpose of report

The purpose of this report is to update members on the current membership of the Calton Area Partnership.

1. Background

- 1.1 At the meeting of the Executive Committee on 28th August 2014 the Governance Framework for the revised community planning structures was approved.

2. Calton Community Council

- 2.1 Calton Steering Group met on Thursday, 9th August 2018 and successfully appointed 7 new members under Delegated Authority by the Community Engagement Officer, bringing them up to their constitutional membership of 12. Steps will now be taken to lift the suspension and re-establish Calton Community Council.
- 2.2 A meeting has been arranged for Thursday, 13th September 2018 to further discuss the Community Council governance, roles & responsibilities and possible Office Bearers to be appointed at their 11th October 2018 AGM, which will include the likely appointment of lead and substitute member for the Calton Area Partnership.

3. West of Scotland Housing Association

- 3.1 Calton Area Partnership at their last meeting on 25th April 2018 had requested that the Director of Governance and Solicitor to the Council write to West of Scotland Housing Association and ascertain if they wished to continue with representation on the Partnership as its representative had not attended the Partnership since 22nd February 2017.
- 3.2 West of Scotland Housing Association Tenants Advisory Group met on Monday, 6th August 2018 and have nominated a representative to replace Anne Young. The required paperwork has been issued and the nominated representative will become a member of the Partnership on completion.
