## **Appendix B- Crime**

# **Violent Crime**

**Overall violent crime** has noted an increase of 1% compared from PYTD and a slight decrease of 0.3% from 5 year mean. The table below provides a breakdown of non-sexual crimes of violence.

### **Violence Against Women and Girls**

The table below outlines crimes usually associated with Violence against Women and Girls.

**Domestic abuse** of females has noted a 2.2% decrease compared to the same period PYTD. There is insufficient data to compare to the 5 year mean.

Rape/ Attempted Rape has noted an increase of 20.8% compared to PYTD, and an increase of 12.2% from 5 year mean for the same period. This increase is reflective of Q1 and Q2 23/24 figures and is the same as the pre-Covid-19 period in 2018/19, when 279 rapes/ attempted rapes were also recorded. It is of note that there are a number of cases where victims have reported several offences. We have also noted an increase in reports from male victims which is an area we have looked to increase public confidence in reporting incidents to police.

In April 2023, Police Scotland published our VAWG Strategy which aims to drive change through the development and effective prevention strategies, the pursuit of perpetrators and the creation of safe spaces for everyone to live freely and safely, ensuring women and girls live free from all forms of violence, abuse, exploitation, and harassment. As outlined in previous reports, in support of the strategy Greater Glasgow PPU have delivered several days of action and informative inputs encouraging reporting of sexual crimes. The increase in sexual crime reporting is encouraging, indicating an increase in public trust and confidence to report these crimes.

**Indecent/ Sexual assaults** have noted a decrease of 5.8% from PYTD, and a decrease of 4.6% from 5-year mean.

#### 16 Days of Activism

A national Domestic Abuse campaign "16 Days of Activism" ran from 25 November 2023 to 10 December 2023 and called for an end to gender based violence.

Supporting the campaign Greater Glasgow Public Protection Unit attended seven High Schools across the East, North West and South of the city and delivered awareness inputs to over 1,000 pupils. These were well received by the pupils themselves who participated in recap sessions to capture and reinforce their learning about Domestic Violence. The popularity of these inputs was widely expressed by head teachers and further arrangements with other High Schools are planned for early 2024. Guidance and support was provided for various partnerships across Glasgow through participation in webinar events, seminars and external calendar events for the 16 days campaign. Campus officers also delivered inputs to five High Schools across the Glasgow South sub division with a focus on coercive and controlling behaviour and online safety. These were also well received and will continue into 2024.

Glasgow City Centre and West areas delivered leaflets and poster at commercial residences, student accommodations and educational establishments across the city.

'I am me' training and awareness was provided to local premises and High schools with the aim of creating safe spaces for women and girls. Safety talks and security guidance for students and staff at Glasgow University were also undertaken in alignment with VAWG strategy.

The 16 Days Campaign provided Greater Glasgow officers the opportunity to promote an end to gender based violence through education, awareness and proactive activity. The efforts of officers from Public Protection and Local Policing have been well received from partners and the public which allows us to conclude that it has been successful and worthwhile.

#### **Anti-Social Behaviour**


Crimes associated with anti-social behaviour have noted decreases compared to PYTD and 5 year mean.



### Fire raising

From the 357 fire-raising crimes recorded this year, 77 were detected. Around 41% of accused were aged 13-18 years.





In Glasgow East the vast majority of incidents were investigated by CID and relate to vehicles being targeted. At this time there is no evidence to infer any of these crimes were committed by youths or indeed linked to Serious and Organised Crime (SAOC).

In Glasgow South-East, in the last year four wilful fire-raisings have been detected, two have been committed by youths aged 11, 14 and 16 years. One incident was a fire to a school shed and the other was setting fire in a toilet within Hampden stadium. Only three in the year were linked to youth disorder. There were two fires linked to an ongoing feud in the Castlemilk area.

In Glasgow South-West there was a spate of wilful fire-raising's where cars were targeted in the same street, no motive or offenders were identified. There are no crimes reported where there are links, through intelligence, to SAOC or youth disorder.

### **Hate Crime**

As outlined on the main report;

Hate Incidents decreased by 5.9% from PYTD and by 4.5% from the 5 year mean, 1206 incidents this year, 1282 incidents PYTD and 5 year mean of 1262.

Hate crime decreased by 11.3% from PYTD, and 13.5% from 5 year mean, with 1078 crimes this year, 1216 crimes PYTD and a 5 year mean of 1246.

Hate crime detections rates have decreased by 3.2% from PYTD and 6.1% from 5 year mean.

## **Appendix C- Community Wellbeing**

## **Seldom Heard Communities**

Greater Glasgow Safer Communities and Local Policing Officers have engaged and interacted with a number of communities during Q3. Engagements included:

- Attendance at the Glasgow Ukrainian Community Integration Network group.
- Engagement with football clubs to ensure the safety and enjoyment of disabled fans at matches.
- Between October and December there were 15 engagements recorded where officers met with communities/groups to gauge community tensions due to the conflict between Israel and Palestine at Synagogues, Mosques, Hindu temples, Jewish business premises, Gurdwaras, education establishments and Kurdish and Islamic community centres.
- Attendance at various regular statutory working groups supporting asylum seekers.
- Attendance at the East Glasgow Integration Network meeting.
- Officers supported the Hate Crime Awareness Week and in conjunction with Glasgow City Council, provided training and attended numerous events throughout the city.
- Officers provided Asian women's group Amina with a hate crime input and commenced community engagement.
- Officers provided inputs regarding hate crime and New Scots to Sharpenher (African Women's Group).
- Officers attended "Never Allowed Ending In-law Abuse" event organised by Amina (Asian women's group).
- Partnership working at Argyle Hotel with Barnardo's in relation to Ukrainian Asylum Seekers.
