SHARED PROSPERITY FUND PROPOSED AMMENDMENTS TO CAPITAL FUNDING AWARDS

Purpose of Report:

The purpose of the report is to update City Administration Committee on the capital funding element of the UK Shared Prosperity Fund, and to seek approval for the proposed amendments to the originally approved funding awards.

1 Background

- 1.1 At its meeting held on 18th August 2022, the Committee agreed the Glasgow element of the Glasgow City Region Investment Plan under the UK Shared Prosperity Fund (UKSPF). The fund will run for the three financial years from 2022/23 to 2024/25.
- 1.2 The fund has three investment priorities: Communities and Place, People and Skills and Supporting Local Business.
- 1.3 To deliver against the aims of the UKSPF, in addition to the revenue funded support outlined in previous committee papers there is also an element of capital funding of £3.6m to be spent by 31st March 2025. A <u>paper</u> providing more detail, and outlining Council's proposed approach to this funding allocation, was presented to CAC on 4th May 2023.
- 1.4 At the City Administration Committee of 17 August 2023, committee approved the allocation of the £3.6m capital as per the table 1.4.1 below:

2. Programme Progress & Governance

- 2.1 As noted in section 3 of the report that was considered by committee on 17 August 2023, Officers from GCC NRS and Legal Services have undertaken robust governance arrangements in relation to: legal agreements with third party grant recipients, specifying project outcomes and timescales, grant claim processes, reporting and monitoring requirements, and where appropriate, clawback and subsidy control clauses.
- 2.2 As with all other UKSPF supported activities within the city, progress with the delivery of the fund has been regularly reported by the council's UK Funds Governance Board, and The Council, through the Glasgow City Region, have been reporting on a quarterly basis on actual and forecast expenditure on all supported activities and providing more detailed information, including data on outputs and outcomes, on a six-monthly basis.
- 2.3 Of the six projects allocated funding, one project has completed all of the appropriate grant paperwork and has already drawn down their funding allocation in full Citizen's Theatre. A further three organisations have concluded their grant agreement paperwork and are now progressing their projects.
- 2.4 During the due diligence and grant agreement stage of the programme, it became apparent that funding offers would require to be withdrawn from one of the projects: Whitevale Baths.
- 2.5 Whitevale Baths has been unable to progress their project due to a funding gap and an inability to establish a funding package that would cover the entire cost of the project, as a result, the SPF allocation will be unable to be drawn down and spent within the timeframe required and therefore the SPF funding offer has had to be withdrawn.
- 2.6 The organisation noted in 2.5 above, has been informed.

3. Funds Redistribution

- 3.1 As a result of having unallocated contingency, and the requirement to withdraw funding offers from 1 of the 6 projects, a total of £454,577 is available for redistribution within the programme.
- 3.2 Given the length of time it can take to get through the due diligence and grant agreement phase of the process, officers are recommending that the available funds be distributed amongst the remaining approved projects, all of which have indicated that they require additional funding to complete their projects as originally planned or, have the ability to enhance their project with additional works.
- 3.3 Table 3.3.1 below, presents the proposed new capital allocations that we are seeking committee approval for:
