Purpose of Report:

To approve grant funding to Green Action Trust in support of Glasgow Tree Plan

Recommendations:

It is recommended that Committee approves the matter of grant funding to Green Action Trust to deliver outcomes in support of the Tree Action Plan, namely:

- An additional £34,287 for Cadder Woods, and
- A sum of £495,000 for Baldragon Road greenspace

1. Introduction

1.1 The Glasgow Tree Plan contributes to the development of the Forestry and Woodland Strategy, the City's Climate Plan and seeks to build on activity being taken across the operational estate to deliver increased canopy cover across the City.

2. Background

- 2.1 A report was taken to Net Zero and Climate Progress Monitoring City Policy Committee on the 12th November 2024 providing an update in relation to The Glasgow Tree Plan, which contributes to the development of the Forestry and Woodland Strategy, the City's Climate Plan and seeks to build on activity being taken across the operational estate to deliver increased canopy cover across the City.
- 2.2 Actions 3 and 4 of the Action Plan relating to the ambition that we further increase our targets for planting by developing new mechanisms and promoting further opportunities with existing funders and stakeholders respectively.
- 2.3 The Environment, Sustainability and Carbon Reduction City Policy Committee <u>paper</u> 27th August 2019 provided an update on the Concordat that Glasgow City Council, along with 18 other Local Authorities, has with Central Scotland Green Network (CSGN) and its delivery arm the Green Action Trust, a registered SCIO with a charitable purpose to improve Scotland's environments for people and for nature.
- 2.4 Guided by this Concordat, Green Action Trust are working with NRS, and a range of communities across Glasgow to bring forward woodland creation and management as part of wider greenspace projects, with this Concordat allowing us to work at scale and pace. In doing so, this allows Green Action Trust to propose projects within Glasgow which align to national priorities, allows Green Action Trust to secure the support of national funders and allows Green Action Trust to resource, at their own risk, initial project development stages from within their own charitable resources.

3. Proposed Grant Award to Green Action Trust

- 3.1 City Administration Committee, at its meeting 31st August 2023, approved £ 772,700 of Vacant and Derelict Land Improvement Fund (VDLIP) funding being utilised by Green Action Trust to bring a long term VDL site in Cadder into actively managed greenspace. Phase 1 of the VDL funded project funded Green Action Trust to support the preparation of a woodland management plan and delivery of early actions, and a further phase of outcomes in support of woodland management, woodland creation, enhanced biodiversity, supporting active travel and outdoor learning across a 14.45-hectare site is now agreed. This has been identified by Cadder residents as key to delivering a quality, multifunctional greenspace within their community.
- 3.2 It is now recommended that approval is given for the level of grant funding to Green Action Trust to be increased by an additional £34,287, from funds held by Glasgow City Council and already approved for such purposes, in order to deliver agreed outcomes at Cadder Woods.
- 3.3 City Administration Committee, at its meeting of <u>16th August 2018</u>, approved £471,000 of Vacant and Derelict Land funding for Easterhouse Relocation Project, to facilitate relation of water vole habitat as well as wider infrastructure and habitat investment at

Baldragon Road, adjacent to Bishop Loch Local Nature Reserve. A review of delivery arrangements was carried out following resolution of land ownership issues with outcomes including removal of redundant road infrastructure, and creation of a multifunctional greenspace including tree planting, habitat creation and enhancement for grassland water voles at this former housing site.

- 3.4 It is now recommended that this Committee approves grant funding of this £471,000, as well as grant funding of an additional £24,000 from funds held by Glasgow City Council and already approved for such purposes, to Green Action Trust to deliver agreed outcomes at Baldragon Road greenspace.
- 3.5 It is considered that Green Action Trust's Concordat, as set out in 2.4, (in for instance leading on NPF4 and the Central Scotland Green Network) enables us to progress our mutual objectives in relation to increased canopy cover through a grant agreement.
