

Provision of taxis and private vehicle hire services framework – Award of contract approved.

7 There was submitted a report by the Director of Legal and Administration regarding tenders received for the provision of taxis and private vehicle hire services framework, advising

- (1) that the Council's annual spend for the provision of taxis and private vehicle hire was £7,923,000;
- (2) that the framework would be utilised by 10 external public sector organisations with an estimated annual spend of £577,000 and supported the Council's statutory obligation to ensure that its employees, service users which included vulnerable adults, children, young people including those with additional support for learning were transported safely and their personal data protected;
- (3) that the contract would be utilised by the Council and 10 external public sector organisations and the period of the framework was 4 years starting from 2nd September 2024; and
- (4) of the 12 suppliers who had accessed the tender, 5 had been taken forward to the award evaluation stage, and following an evaluation, it was recommended that the contract be awarded to the suppliers, as detailed in an appendix to the report.

After consideration, the committee approved the award of a framework for the provision of taxis and private vehicle hire services at an estimated annual award value of £10,106,500, to the following suppliers:-
