Regional Economic Strategy Action Plan - Update for 2024/25

Purpose of report:

This report provides the Cabinet with the update of the Regional Economic Strategy (RES) Action Plan for 2024/25.

1. Purpose

1.1 This report provides the Cabinet with the update of the Regional Economic Strategy (RES) Action Plan for 2024/25.

2. Background

2.1 The Regional Economic Strategy was approved by Cabinet in December 2021 with the Action Plan subsequently approved by Cabinet in August 2022. Delivery of the actions within the document are monitored through by the PMO and reported to the Regional Partnership and Cabinet.

3. Scope of the Updates

- 3.1. The process to update the Action Plan was undertaken by the GCR PMO, in consultation with the Economic Delivery Group, prior to moving into the 3rd year of delivery, and reflect progress made to date in delivering the initial actions, removing those actions previously marked as completed or superseded, and adding in new actions.
- 3.2. The proposed changes are to the Action Plan, not the Regional Economic Strategy where the grand challenges and missions remain unchanged.
- 3.3. Since approval of the first Action Plan in August 2022, there have been significant developments to the policy context, both nationally and within Glasgow City Region. These include:
 - securing over £350 million of additional investment to the City Region through the Shared Prosperity Fund, Innovation Accelerator, Investment Zone, Clyde Mission;
 - the ongoing City Deal Reprogramming exercise;
 - the adoption of Community Wealth Building objectives;
 - national policies in relation to Net Zero; and,
 - changes to the skills system, signalled through the Withers' Report.
- 3.4 An updated version of the Action Plan is attached as an Appendix. In addition to the updates proposed as part of this annual review and summarised in the following paragraphs, additional actions will be added to the Action Plan throughout the year as required.
- 3.5 The updates to the draft RES Action Plan for 2024/25 include:
 - Bringing together the development of the GCR Investment Zone and development of a GCR Investment Fund into a new 'Investment Programme';
 - Updated actions for the **Clyde Mission** Programme (*Actions 7 & 8*);
 - A new 'Sustainable City Region Programme' that brings together actions on the Green Network Blueprint, Clyde Climate Forest, and the Climate Adaptation Strategy Action Plan (Actions 11-13);
 - Updated actions for the **Housing Retrofit Programme** to include the development of a GCR Retrofit Strategy (*Action 15*);

- Updating of the actions in the 'Future Skills Programme' to include the actions of the Regional Skills Devolution Group, Local Government Skills activity, development of skills programmes for the Investment Zone and Innovation Action Plan, and delivery of Multiply (Actions 19-26);
- A new 'Economy and Health Programme' bringing together activity to around the fair and healthy work business case, Living Wage Place accreditation, Good Employment Charter, and Economies for Healthier Lives (Actions 27 31);
- A new 'Inclusive Economy Programme' that aligns the community wealth building themes of progressive procurement, shared ownership, and finance, with the Foundational Economy Delivery Plan delivery of the 5G Innovation Region business cases (*Actions 32 36*);
- The 'Green Business Support Programme' has a new action to evaluate the current activity in Q3 2024/25 to inform medium to long term arrangements (Actions 37 39): and.
- A new 'Commercial Land and Property Programme' that brings together the completion of the Vacant & Derelict Land business case to include the ongoing commercial assessment of the priority V&DL sites, the energy efficiency analysis of commercial and industrial premises in GCR, creation of economic dashboards for GCR's largest town centres, and creation of a new regional project to provide support for Commercial Property & Land development (*Actions 42 47*).

4 Consultation

4.1 The updated Action Plan was presented to the Economic Delivery Group and the Regional Partnership for comment prior to submission to Cabinet for approval.
