Introduction

1. The purpose of this paper is to notify Cabinet of the Members of the new Regional Spatial Planning Sub-committee (RSPS) nominated by Member Authorities (MAs) and to seek approval for the sub-committee's Terms of Reference.

Background

- 2. On the 28th of June 2023, the Clydeplan Joint Committee agreed a recommendation to transfer the responsibility for oversight of the development of a Regional Spatial Strategy to the GCR Cabinet.
- 3. At the meeting on 13th February 2024, Cabinet agreed to establish the RSPS.

GLASGOW CITY REGION REGIONAL SPATIAL PLANNING SUB-COMMITTEE

TERMS OF REFERENCE

Membership: 16 Members comprising 2 Elected Members appointed from each of

the Glasgow City Region Member Authorities.

Chair: The Committee shall elect biennially a Convener and Vice-

Convener from Members both of whom shall continue in office until the first meeting of the Committee which takes place after First April

in the second year following their election.

Quorum: The quorum of the Committee shall be four Members provided

that no fewer than four of the Member Authorities are represented.

Meeting arrangements: Minimum 2 meetings per year.

Attendees: The Glasgow City Region Head of Place and Chief Planning

Officers and/ or relevant Senior Officers from each Member Authority or their representatives will attend the Committee.

Terms of Reference:

1. To oversee the preparation of a Regional Spatial Strategy for the Glasgow City Region.

- 2. To oversee the preparation of other spatial strategies and plans for the Glasgow City Region or part thereof as may be delegated from the Glasgow City Region Cabinet from time to time.
- To advise and make recommendations to the Member Authorities on the policy content of the Regional Spatial Strategy and other spatial strategies, including the adoption of the Regional Spatial Strategy by Member Authorities, its submission to the Scottish Ministers and its subsequent monitoring and review.
- To liaise with and make representations to the Scottish Government and other bodies as necessary on matters of relevance to strategic spatial planning in respect of the Glasgow City Region.
- 5. To provide reports to Member Authorities and the Glasgow City Region Cabinet.
