The Supply, Installation, Management and Maintenance of Secure Cycle Storage Units

**Tender Reference: - GCC005733CPU** 

#### **Purpose of Report:**

To submit details of the tenders received for the supply, installation, management and maintenance of secure cycle storage units and recommend acceptance of the most economically advantageous tender as detailed in this report.

#### Recommendations:

The Contracts and Property Committee is requested to approve the award of a contract for the supply, installation, management and maintenance of secure cycle storage units to the supplier listed below.

#### 1 Background and Tender

- 1.1 Glasgow City Council's ("the council's") budget for the supply, installation, management and maintenance of secure cycle storage units is £2.5 million. This budget figure was calculated based on the existing cost for cycle storage units plus a forecasted increase based on client estimates.
- 1.2 The issue of residential cycle parking is a problem for the council where there is a sizable proportion of older tenement properties and a limited space available for cycle storage. In recognition of this, the council awarded a 'pilot' contract for Secure On-Street Cycle Shelter Provision (SOSCP) for residents in March 2021. 61 units were installed in Phase 1 during May 2021 with an additional 70 units being installed in Phase 2 during March 2022. After that, Phase 3 was completed by installing additional 74 units with an uplift of the original contract value which led the total number of 205 units. Overall, the pilot has performed well with an average 96% occupancy (as of September 2023) across all units and a waiting list nearing 3,000.
- 1.3 Following a report to committee in March 2022, the council made a commitment to expand provision of the scheme with initial funding of £1.5m from the council's capital programme. This figure was subsequently increased to £2.5m.
- 1.4 The new shelters shall have a capacity of storing no less than six (6) bikes per shelter and will be suitable for many of the popular iterations of bicycle (road, mountain, city, ebikes etc.) in use at present.
- 1.5 The council anticipates that 500 new shelters shall be installed during the 5-year contract period, subject to market rates. As part of this contract, the council is targeting the supply and installation of approximately 120 shelters within 12 months of the contract commencement date, a further 120 shelters will be the target for installation in year 2, and a further 120 in year 3. The remainder shelters will be purchased and installed over the duration of the contract.
- 1.6 Further units may be required and installed subject to demand and available budget. This scheme will be developed in subsequent contract years in line with unit cost, demand, and available budget.
- 1.7 A commodity team consisting of stakeholders from Neighbourhoods, Regeneration and Sustainability and the Corporate Procurement Unit was formed to develop the sourcing strategy and deliver a new contract.
- 1.8 It was agreed that an open tender process would be the most appropriate method to deliver this contract. The opportunity was advertised via UK Find a Tender Service and Public Contracts Scotland.
- 1.9 The duration of the contract is 5 years with the option to extend for 2 periods of up to 12 months.
- 1.10 The contract will be utilised by Neighbourhoods, Regeneration and Sustainability.

#### 2 Evaluation

- 2.1 10 suppliers expressed an interest. Of the 10, 3 submitted a bid. Of the 7 suppliers that failed to respond, two cited the opportunity was not suitable for their organisation, one cited insufficient capacity at this time, one cited inability to fulfill all elements of the contract, and the remaining 3 suppliers declined to provide a reason.
- 2.2 The award evaluation was based on the following criteria and weightings:-

2.3 The evaluation of award scoring and award/evaluation value of the supplier which has been recommended for award is shown in the table below:-

\*The figure above represents a combination of the cost of purchasing the shelters plus repair and maintenance. The shelter element comprises the majority of the spend and based on the existing pricing represents a 24.9% saving when compared to existing shelter costs. The labour element of repair and maintenance represents a 58.3% saving when compared to existing labour costs.

A summary of the unsuccessful tender evaluation results can be found at Appendix A.

#### 3 Contract implementation and Supplier Management

3.1 The outcome of our Contract Management Assessment Tool (CMAT) has deemed this contract to be categorised as a low. The supplier will be monitored in line with our contract and supplier management process which includes

tracking the supplier's performance against the key performance indicators and working collaboratively to identify opportunities of improvement and innovation.

3.2 The agreed community benefits outcomes and Fair Work First commitments will be monitored via Cenefits which is a web based monitoring tool. We will also capture sustainable commitments within the CPU Sustainable Register.

As detailed in paragraph 2.3, savings have been secured on both the shelter cost and the repair and maintenance cost compared with existing rates. As a result, further units could be installed subject to demand and available £2.5M budget at the

discretion of the client.
