1 Introduction

- 1.1 The Community Empowerment (Scotland) Act 2015 places a requirement on Community Planning Partners to publish a Local Outcome Improvement Plan (LOIP) setting out shared priorities for the city, where we plan to make improvements and how we will demonstrate progress towards these goals.
- 1.2 Glasgow has a long history of partnership working between local communities and city organisations. By working in partnership we have been able to regenerate and transform large parts of our city.
- 1.3 The significant progress that has been made tackling many of the persistent social issues that have blighted local communities has made Glasgow's approach an international example of best practice.
- 1.4 The Community Planning Partnership's vision is for Glasgow to be a world class city, with thriving and resilient communities where everyone can flourish and benefit from the city's success.
- 1.5 This can be best achieved by continuing our partnership approach, bringing national, city and local organisations together to share expertise and achieve mutual goals. By discovering better ways of working we can break down common barriers and find new ways to empower communities to achieve their own goals.

2 The Draft Glasgow Community Plan

- 2.1 Glasgow's draft LOIP - The draft Glasgow Community Plan has been produced by the Glasgow Community Planning Partnership which brings together public agencies, the business community and the third sector to improve the city, local services and the lives of people who live and work here. The plan has been attached as appendix to this report.
- 2.2 The Glasgow Community Plan will bring together Community Planning Partners, wider city partners and local communities to deliver lasting benefits to local communities and residents. The Plan priorities were informed by years of community engagement and partnership working.
- 2.3 Key priority headlines identified in the draft plan were Economic Growth, Resilient Communities, and A Fairer and More Equal Glasgow.
- 2.4 Specific actions in each of these priority areas will allow Partners to better deliver long-term benefits for local communities. Using pooled resources and expertise to tackle unemployment and underemployment, poverty and ill-health, and promote a more inclusive economic growth to ensure everyone can benefit from the city's wider success and is supported to achieve their own potential.
- 2.5 Two priority action areas were also been identified and have been included in the consultation.

- 2.5.1 **Transport** – Partners identified a priority to ensure people and communities are connected to local and city services, opportunities, learning and jobs and to tackle social isolation and mental wellbeing.
- 2.5.2 **Accessible and Affordable Childcare** - This was identified as a gateway to learning and work opportunities for parents and carers. Improving access and provision will create a greater opportunity for a good start in life and tackle poverty, particularly in work poverty.
- 2.6 The Final Plan will report annually on its progress towards identified 1 year, 3 year and 10 year targets.
- 2.7 A two month public consultation was launched by Bailie Robertson on Friday 30th June at the Pearce Institute in Govan. The purpose of the consultation is to ensure the Glasgow Community Plan belongs to the entire city, with priorities shaped not just by Partners but by the public and community groups.

- 2.9 An extensive promotion plan has been undertaken with Partners promoting the draft Community Plan and survey response to their own member organisations and community partners.
- 2.10 The Plan and consultation survey have also been actively promoted by many local, city and national organisations, particularly through their online and social media channels.
- 2.11 To ensure that as many Glasgow citizens and organisations can access the Consultation and make their views heard, the consultation documents have been translated into Polish, Urdu, Punjabi and British Sign Language.
