CABINET MEMBERSHIP UPDATE

Purpose of Report:

To notify the Cabinet of the revised membership following the recent local government elections and advise of the procedural rules governing Cabinet meetings.

Recommendations:

It is recommended that the Cabinet notes

- (1) the revised membership and substitutes;
- (2) that the Cabinet members' Register of Interests will be submitted to the next meeting; and
- (3) the procedural Standing Orders governing Cabinet meetings.

1. BACKGROUND

1.1 The agreed City Deal Assurance Framework sets out the Cabinet governance structure, including membership.

2. CABINET MEMBERSHIP

- 2.1 Membership of the Cabinet is made up of the Leaders of each of the Member Authorities. Each Member Authority may name a substitute who may attend Cabinet meetings. Where a Leader or substitute is unable to attend a Cabinet meeting the Member Authority may appoint another substitute provided that appropriate written notice is given in advance to the Clerk.
- 2.2 The revised Cabinet membership and substitutes, following the recent local government elections are as follows:-

2.2 The Cabinet may invite other consultees or bodies to attend Cabinet meetings as deemed appropriate, but they will not have any voting rights.

3. CHAIR

3.1 The Assurance Framework specifies that the Chair of the Cabinet will be the Leader of Glasgow City Council.

4. REGISTER OF INTERESTS

4.1 The Assurance Framework also specifies that each member of the Cabinet is required to make a declaration of interests, which will be collated for all members of the Cabinet and substitutes and published on the Cabinet website. Register of Interests forms will be issued to all Cabinet members and

substitutes for completion so that the full Register of Interests can be submitted to Cabinet at its next meeting in August.

5. CABINET PROCEDURAL STANDING ORDERS

5.1 At its first meeting on 20th January 2015 the Cabinet approved procedural Standing Orders to govern its meetings. The Standing Orders, which were agreed by all 8 Member Authorities, are attached as Appendix 1. No changes have been made to those Standing Orders.

6. **RECOMMENDATIONS**
